**ORDINANCE AMENDING HUMBOLDT COUNTY CODE SECTION 421-3 RELATING TO BOULEVARD STOPS IN THE EUREKA AREA; AMENDING SECTIONS 422-7, 422-8, 422-9, 422-10, 422-11 AND 422-12 RELATING TO SPEED LIMITS IN THE EUREKA, FORTUNA, GARBERVILLE, LOLETA, MCKINLEYVILLE, AND REDWAY AREAS; ADDING SECTIONS 431-14.1, 431-14.2, AND 431-83 RELATING TO PARKING IN THE MCKINLEYVILLE AREA; AMENDING SECTION 432-1 REGARDING BUS LOADING ZONES IN THE EUREKA AND FORTUNA AREAS; ADDING SECTIONS 435-2, 435-4, AND 435-5 RELATING TO BICYCLE LANES AND BIKEWAYS; AMENDING SECTION 435-3 RELATING TO BICYCLE LANES AND BIKEWAYS, ALL OF TITLE IV OF THE HUMBOLDT COUNTY CODE BY TITLE AND WAIVE THE FIRST READING**

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. Section 421-3 of Chapter 1 of Division 2 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 2. Sections 422-7, 422-8, 422-9, 422-10, 422-11 and 422-12 of Chapter 2 of Division 2 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 3. Sections 431-14.1, 431-14.2, 431-83 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code is hereby added as shown on the attached pages.

SECTION 4. Section 432-1 of Chapter 2 of Division 3 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 5. Sections 435-2, 435-4, and 435-5 of Chapter 5 of Division 3 of Title IV of the Humboldt County Code is hereby added as shown on the attached pages.

SECTION 6. Sections 435-3 of Chapter 5 of Division 3 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 7. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

**431-14.2. Parking on Boeing Court.**

The parking of vehicles is hereby prohibited at all times on both sides of Boeing Court in McKinleyville (County Road No. 4M205). (Ord. \_\_\_\_\_, § \_\_\_\_\_, / /2024)

**431-83. Parking on Nursery Way**

The parking of vehicles is hereby prohibited at all times on both the sides of Nursery Way in McKinleyville (County Road No. 4L937) from Central Avenue (County Road No. A4L800) to a point 0.069 mile (0.111 km) north of Heartwood Drive (County Road No. 4L980) (Ord. \_\_\_\_\_, § \_\_\_\_\_, / /2024)

**432-1. Establishment of Various Bus Loading Zones.**

**CHAPTER 5**  
**BICYCLE LANES AND BIKEWAYS**

**435-2. Establishment of Class I Bikeways**

The following Class I Bikeways are hereby established:

(a) East side of Fischer Avenue (County Road No. 4L830) from the westerly leg of School Road (County Road No. A3L070) to Montana Road.

(b) North side of Murray Road (County Road No. C3M020) from 60 feet westerly of Daffodil Avenue (County Road No. 4M110) to U.S. 101.

(c) West side of Sagewood Way (County Road No. 4L992) from the prolongation of the north line of Lot 40, Tract No. 647, filed in Book 25, pages 48 through 51, of Maps, in the Office of the County Recorder of said County to the prolongation of the east line of Parcel F, of said Tract 647.

(d) On Parcel F, adjacent to Sagewood Way (County Road No. 4L992) as shown on Tract No. 647, filed in Book 25, pages 48 through 51, of Maps, in the Office of the County Recorder of said County.

(e) South side of School Road (County Road No. A3L070) from Ocean Drive (County Road No. C3L080) to Fischer Road (County Road No. 4L830).

(f) West side of Washington Avenue (County Road No. A4L925) from 220 feet north of School Road (County Road No. A3L070) to 150 feet south of Oakdale Drive (County Road No. 4L928).

**435-3. Establishment of Class II ~~Bicycle Lanes~~ Bikeways.**

The following Class II ~~bicycle lanes~~ Bikeways are hereby established:

**435-4 Stopping or Parking of Vehicles Prohibited**

No person shall stop, park, or leave standing any vehicle in a Class I or Class II Bikeway, except for maintenance and construction vehicles permitted by the Director of Public Works.

**435-5 Motor Vehicles Prohibited**

No person shall drive, propel or cause to be propelled any motorized vehicle on or upon any Class I Bikeway except as follows:

1. motorized vehicles legally operated upon a permanently constructed driveway that crosses a Class I Bikeway, for the sole and limited purpose of crossing such Class I Bikeway;
2. motorized maintenance and construction vehicles permitted by the Director of Public Works;
3. motorized law enforcement, fire department, and ambulance vehicles.
4. motorized vehicles that are otherwise lawfully permitted to use a Class I Bikeway, such as battery-powered wheelchairs.
