## RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING EXECUTION OF STATE OF CALIFORNIA STANDARD AGREEMENT NOS. 0000000364 AND 0000000390 WITH THE CALIFORNIA EMPLOYMENT DEVELOPMENT DEPARTMENT REGARDING THE PROVISION AND RECEIPT OF EMPLOYMENT RECORDS PURSUANT TO CALIFORNIA UNEMPLOYMENT INSURANCE CODE SECTIONS 1095(i) AND 1095(o)

**WHEREAS,** pursuant to Sections 1095(1) and 1095(0) of the California Unemployment Insurance Code, the County of Humboldt may enter into State of California Standard Agreements with the California Employment Development Department regarding the provision and receipt of certain employment records for the purpose of conducting Felony Crime and Workers' Compensation Fraud investigations; and

**WHEREAS**, the County of Humboldt, by and through the Humboldt County District Attorney's Office, has determined that there is a need for the California Employment Development to provide certain employment records in order to properly conduct Felony Crime and Workers' Compensation Fraud investigations.

# NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The Humboldt County Purchasing Agent, and/or designees thereof, are hereby authorized and directed to execute and deliver, in accordance with any and all applicable local, state and federal laws, regulations and standards, State of California Standard Agreement Nos. 0000000364 and 0000000390, and any amendments thereto, along with any and all other agreements, certifications, attestations and documents required or deemed necessary or appropriate for the Humboldt County District Attorney's Office to accept and secure the provision and receipt of certain employment records for the purpose of conducting Felony Crime and Workers' Compensation Fraud investigations and the County of Humboldt's obligations related thereto.
- 2. The County of Humboldt hereby certifies that it will accept the provision of certain employment records pursuant to Sections 1095(1) and 1095(0) of the California Unemployment Insurance Code in a manner consistent, and in compliance, with the terms and conditions of set forth in State of California Standard Agreement Nos. 0000000364 and 000000390, as well as any and all applicable local, state and federal laws, regulations and standards and other applicable agreements between the County of Humboldt and the California Employment Development Department.
