

**FIRST AMENDMENT
AGREEMENT FOR CONSULTANT SERVICES
BY AND BETWEEN
COUNTY OF HUMBOLDT
AND
QUINCY ENGINEERING, INC.
AS ASSIGNED TO
CONSOR NORTH AMERICA, INC.
FOR
DESIGN ENGINEERING AND ENVIRONMENTAL SERVICES
FOR THE HOLMES-LARABEE BRIDGE PROJECT**

This First Amendment to the Agreement for Consultant Services dated April 24, 2018, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and Quincy Engineering, Inc., a California corporation, as assigned to Consor North America, Inc., an Illinois corporation, hereinafter referred to as “CONSULTANT,” is entered into this ____ day of _____, 2023.

WHEREAS, on April 24, 2018, COUNTY and CONSULTANT entered into an Agreement for Consultant Services regarding the provision of design engineering and project development services for the Holmes-Larabee Bridge Project (“Consultant Services Agreement”); and

WHEREAS, pursuant to Article 1, Provision D of that agreement CONSULTANT must obtain the COUNTY’s written approval to assign obligations thereunder; and

WHEREAS, the COUNTY now explicitly agrees in writing to such an assignment of CONSULTANT’s obligations from Quincy Engineering, Inc. to Consor North America, Inc. pursuant to Article 1, Provision D of the Consultant Services Agreement.

NOW THEREFORE, the parties mutually agree as follows:

1. Article 1 – Introduction of the Consultant Services Agreement is hereby amended to read as follows:

ARTICLE I – INTRODUCTION

- A. The Project Manager for CONSULTANT will be Jason Jurrens. The Contract Administrator for COUNTY will be Tony Seghetti, Deputy Director of Public Works or a designee thereof.
2. Article XXV – Insurance and Indemnification of the Consultant Services Agreement is hereby amended to read as follows:

ARTICLE XXV – INSURANCE AND INDEMNIFICATION

- C. Any and all insurance notices required to be given pursuant to the terms of this Agreement shall be sent to the addresses set forth below in accordance with the notice provisions described herein.
