TITLE: Consider the Gateway Area Plan Planning Commission Recommendation.

## **RECOMMENDATION:**

It is recommended the Council consider the recommendation of the Planning Commission, review Councilmembers' proposed changes, and provide direction to the Commission and staff regarding the Gateway Area Plan and implementing ordinances. The Council should also consider public comment on this item.

#### INTRODUCTION:

The Planning Commission completed its initial review of the Gateway Area Plan and the Gateway Code on July 11, 2023, and provided a recommendation to the Council for adoption. This study session provides the opportunity for the Commission to discuss its recommendation with the Council. While the discussion may address anything in the Plan or the Code, the Mayor, with input from the Planning Commission Chair, has identified building height, the K and L Street couplet, and inclusionary zoning as topics to prioritize for this first meeting. The Council will have the opportunity to provide recommended changes using a similar framework that the Commission used.

#### **BACKGROUND:**

The Commission's July 11 recommendation has been conveyed to the City Council. The Gateway Area Plan has been updated to reflect the Commission's recommendation (Attachment A). The recommendation was made in light of the many Committees' recommendations, which can be viewed at <a href="https://www.cityofarcata.org/940/Engagement-Information">https://www.cityofarcata.org/940/Engagement-Information</a> and as cataloged below. This meeting is an opportunity for the Council to weigh in on this important policy matter.

## **DISCUSSION:**

### **Process**

The Mayor will address the topics in turn that are of primary interest to the Council and community inviting comment from the Planning Commission Chair first, then entertaining discussion from Commissioners and Councilmembers. The discussion should be followed by direction, which may be given by any method adopted in the Council framework, which the Council will have adopted at

an earlier point in this meeting. Staff has provided a draft of the Council framework (Attachment B) to describe a proposed decision-making process that worked effectively for the Commission.

The Council should cover at least the proposed building heights, the K and L couplet, and the inclusionary zoning topics. The Council may use the policy pitch process (Attachment C) to address these topics and any other proposed changes. To effectively implement this process, Councilmembers should provide any feedback on proposed changes the Friday before the meeting at noon. Staff will compile recommendations into a discussion guide for the Council's use. The Mayor will use the framework for arriving at decisions on the proposed changes.

Councilmembers are encouraged to use the policy pitch format for ease of review in the meeting in their comments submitted to staff. The compiled discussion guide will be provided to the Council, Commissioners, public, the lobby binder, and the SIRP page by 5:00 the Friday before the meeting, providing simultaneous notification and release of information to all interested parties.

Councilmembers may wish to consult the decision matrix (Attachment D) to orient to where in the Gateway Area Plan the primary topics are considered.

In addition to the above resources, the PowerPoint on inclusionary zoning (Attachment E, and at https://youtu.be/053dAE3DsVc) and the Draft Community Benefits Program (Attachment F), may help facilitate the Council's discussion.
