- ① FOUND 5/8" REBAR WITH CAP MARKED "DRAKE LS 9244" PER (R1).
- ② FOUND 1-1/2" BRASS CAP IN MONUMENT WELL MARKED "LS 2820" PER (R2).
- ③ FOUND NAIL & 3/4" BRASS TAG IN CONCRETE CURB MARKED "LS 2820" PER (R2). ACCEPTED AS THE TRUE REFERENCE POINT PER (R2). LIES 1.60' N02°E OF RECORD POSITION (R1) AND 0.19' N18°E OF THE TRUE CORNER POSITION AS CONTROLLED BY THE CENTERLINE OF PONDEROSA COURT AND MONUMENTED PER (R2).

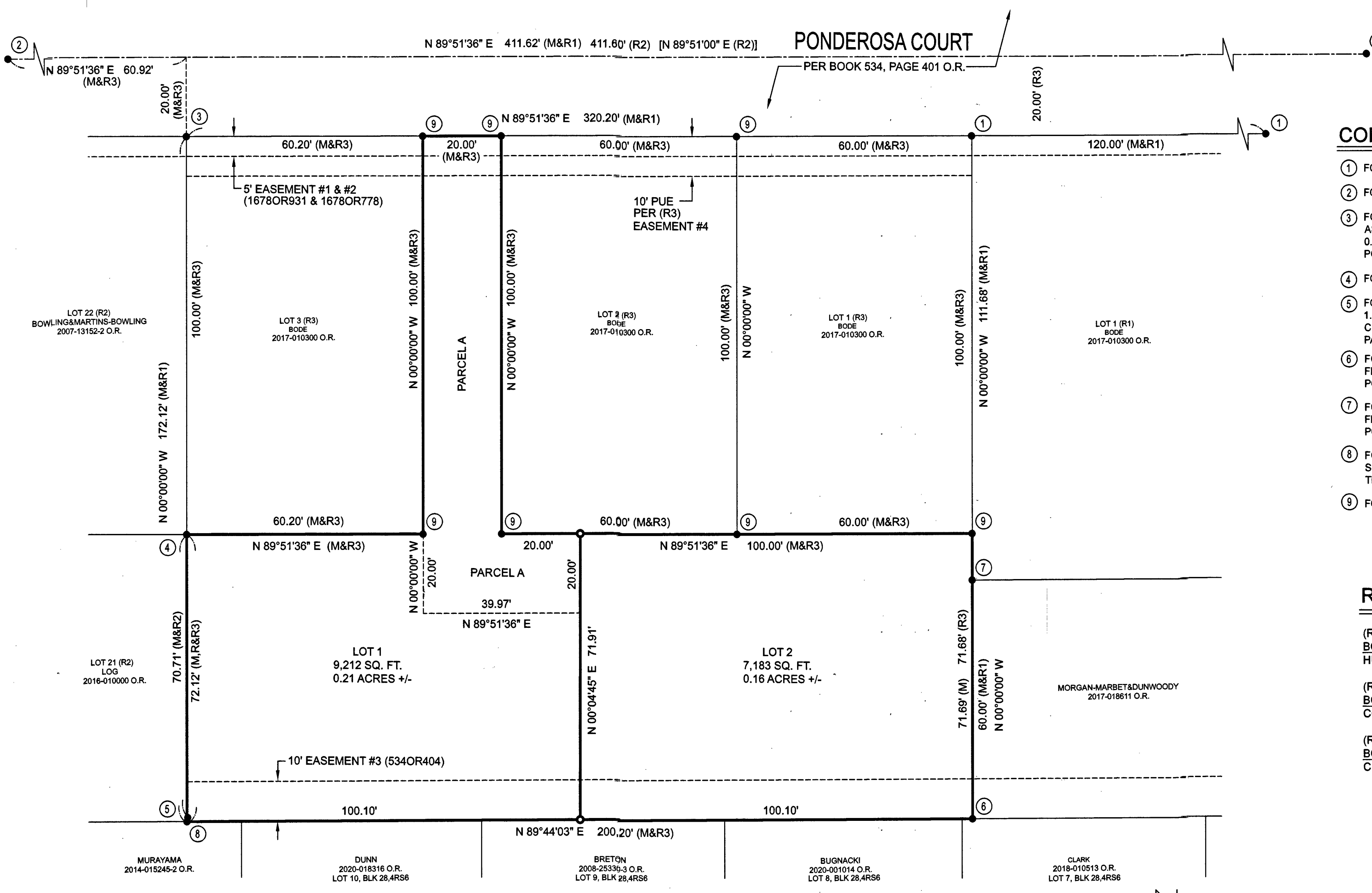

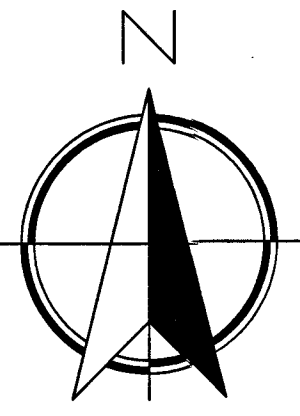
