Currently working as the California Timberlands (CAT) Security Patrol. My duties consist of patrolling properties belonging to Green Diamond Resource Co., within the California Operational location. Duties include dealing with trespass issues, protesters, homeless encampments, theft of commodities, and providing access to approved visitors and contractors. Maintaining gates across the landscape and tracking and issuing keys associated with access to the property is also part of the job. As of January 2023, my position has been absorbed by the CAT Real Property Department and now includes helping with potential business development opportunities, land purchases, and managing real property assets. Aside from my role in Security Patrol, I also serve as the only heavy-lift drone pilot. Part of my role as a Drone Pilot includes participating in the CA Timberlands safety program. The drone is currently being utilized to assist Hook Tenders in setting up yarder road lines. I also participate in the company safety program and present specific topics during quarterly safety compliance training.

Currently serving as a board member for North Coast Regional Land Trust and the Humboldt/Del Norte Cattlemen's Association. In these positions, I have become involved with Land Use issues as well as agriculture-related issues and uses. I have also seen the challenges of the permitting process regarding development and conservation.

While serving as a Humboldt County Sheriff's Investigator for the Criminal Investigations Division, my duties included, but were not limited to investigating major crimes within the boundaries of Humboldt County, collecting evidence of crimes, preparing, and serving search warrants. Preparing in-depth reports for successful prosecution. Before my promotion to Sheriff's Investigator, I was assigned to the Sheriff's Special Services Division as the Livestock Deputy, a

position I held for approximately 7 years. Duties included rural crime investigation, assisting the Humboldt County Drug Enforcement Unit, assisting the Humboldt County Drug Task Force, as well as the Drug Enforcement Administration, and CADOJBNE (California Department of Justice Bureau of Narcotics Enforcement) While working with these different agencies, I assisted in gathering intelligence for search warrants, serving search warrants, and collecting evidence. While working in Special Services, I assisted and managed numerous search and rescues, worked with local ranchers and timber companies investigating trespass issues and commodities thefts, and conducted investigations into industrial accidents.

I started my career with The Pacific Lumber Company working in mill systems, operating several pieces and types of equipment utilized in the production of rough lumber and finished products. After transferring to the woods operations, I worked in all aspects of the logging industry from setting chokers behind heavy equipment and yarders, landing man, tree climber, and heavy equipment operator on both the logging side and the road construction side. During winter months I worked with the company fish trapping program for their hatchery and oversaw contract tree planting crews.
