I'm working on the staff report for a cannabis project (APPS #11949 – Burr Road, LLC; site plan attached), located in the Briceland area. Access to the site is via a private drive off Old Somerville Creek Road (which traverses the site; non-County maintained), via Old Briceland to Briceland Thorne Road (both County-maintained). A Road Evaluation Report was prepared for the applicant by Six Rivers Construction and Consulting (dated July 6, 2018; attached) for a 1.9-mile segment of Old Somerville Creek Road which indicates that the roadway is not developed to the equivalent of road category 4 or better, but can accommodate the increased traffic from the proposed use. There will be a maximum of four (4) people onsite during peak operations.
