

## Child Abuse Prevention Coordinating Council (CAPCC) of Humboldt Annual Report 2022

The Child Abuse Prevention Coordinating Council of Humboldt County (CAPCC) is a broad-based non-profit advocacy organization that works to eliminate child abuse and neglect in our community through (1) striving to assure coordinated services and policies for the prevention, intervention and treatment of child abuse among agencies and organizations, (2) actively promoting and supporting high-quality programs that successfully reduce child abuse and neglect and (3) increasing public awareness of resources to help prevent child abuse and decrease family stress. Our Mission is:

***Strengthening community connections to promote safe, healthy, resilient children and families in Humboldt.***

In our 2021 report we discussed CAPCCs participation in the creation of a Primary Child Abuse Prevention Plan. During 2022 we have continued to build upon the work as we aligned with DHHS, through the Family First Prevention Services Act (FFPSA), to assist in the development of a Comprehensive Prevention Plan (CPP) for Humboldt County. The CPP includes not only primary prevention but also secondary and tertiary prevention. CAPCC worked closely with DHHS to incorporate our Primary Prevention Plan, created in 2020, into the three-year CPP. CAPCC also recommend to Child Welfare Services (CWS) that the Children's Trust Fund (2022-2025) be distributed equitably to the 16 Family Resource Centers, the 3 tribes and HCTAYC, who comprise the Community Pathway of the CPP, to support primary and secondary prevention activities. CAPCC felt that by taking the lead and demonstrating ways that prevention dollars could support the CPP, CWS would begin to realign their prevention dollars over time, which are primarily utilized in-house. This reallocation would occur as CWS's workload decreased, which is the anticipated outcome of the CPP. In November CAPCC was approached by Strategies 2.0, who provide technical assistance to all of the counties implementing FFPSA, to present on CAPCC's long standing collaboration with the Humboldt Network of Family Resources Centers (HNFRC) and how that supported the creation of the CPP. The presentation, presented by both CAPCC and HNFRC, was 12/14/22.

We added the Child Protection Reporting Guide (CPRG), the first in our nation, to our website. The CPRG was created as a result of the Attorney General's stipulations to Humboldt County CWS. The guide can be used by both mandated reporters and the general public to assist them in determining if they should report suspected abuse to CWS.

CAPCCs board has maintained a seat on the California Citizen's Review Panel addressing child abuse, for several years. This report year, our board member and Citizen's Review Panel designee, Jan Bramlett, addressed the National Citizens Review Conference in Asilomar, on mandated reporting. CAPCC's new project is to improve and standardize virtual mandated reporter training throughout the county. CAPCC formed a committee to begin working on this. We anticipate that this will take about a year to complete.

Ashley Gephart, Public Health Branch – Community Health Improvement Plan coordinator joined CAPCC Board, strengthening the partnership between CAPCC and Public Health, and providing a direct conduit for CAPCC input to the county’s CHIP. CAPCC’s recommendation to include Adverse Childhood Experiences (ACEs) as a focus area was heard. CAPCC was participated in the data work groups, held in 2022, supporting the CHIP, Live Well Humboldt.

During April which is Child Abuse Prevention Month, CAPCC accomplished the following:

- 1) Spring e-Newsletter in Spanish and English distributed via email, on our website and Facebook page,
- 2) The Truth Works a 60-second radio spot highlighting April as Child Abuse Prevention Month,
- 3) Provided a 15 minute interview on our Spanish only radio station highlighting April is Child Abuse Prevention month and the work that CAPCC is doing,
- 4) Provided blue pinwheels for pre-school children parades during April, which is also the month of the Young Child.
- 5) Accepted a proclamation from the Board of Supervisors on April 5<sup>th</sup>.
- 6) Arranged for street banners to be hung in Eureka and Arcata.
- 7) Arranged for marquees throughout Humboldt County to display April as Child Abuse Prevention Month and list our website,
- 8) Arrange for the children’s memorial flag rising to occur on the 4<sup>th</sup> Friday of April at the Eureka Boys & Girls Club Teen Center.
- 9) Recognized Kathryn O’Malley and the Nurse Family Partnership Program, Valetta Molofsky and the Humboldt County Black Music and Arts Association, and the Seventh Generation House in Fortuna as our 2022 Children First recipients. Their accomplishments to reduce or prevent child abuse were posted on our Facebook page.

During 2022 the CAPCC Board participated in a survey that CalTRIN, a contracted training arm of the California Department of Social Services (CDSS), provided on Direction, Alignment and Commitment. We presented the survey results at our February meeting and set up a committee to develop a Board Orientation.

Through our website, Facebook page and Instagram we have expanded CAPCC’s social media footprint. As an example, we have posted child vaccination clinic schedules, our newsletters in both Spanish and English, training opportunities and all of our April activities.
