Chairman Madrone and members of the Board:

My name is Bruce Cann and I live in Eureka. Thank you for the opportunity to comment on the previously proposed vacation of a portion of Fisher Road in Hydenville.

This letter represents myself as a community member only. It does NOT represent the views of the Humboldt County Fish & Game Advisory Commission.

This letter includes my comments on the most recent Staff Report (File #: 22-1574) for the Supervisor's meeting on 12/20/2022 (which never occurred due to the earthquake), as well some suggestions/comments.

I suggest the Board vote in favor of expending funds directed toward ensuring the public's right to continue using Fisher Road to access the navigable Van Duzen River. This should be done by obtaining **deeded** access along Fisher Road. **As stated on page 3 of the Staff Report, "Because the county is maintaining a public road, the county is obligated to perfect a public right of way for what it is maintaining."**

The next bullet on page 3 states "The county is not obligated to assert an implied common law dedication for the remainder of Fisher Road beyond where the county maintained road ends." In my own personal opinion, the County is obligated to extend the dedication to the navigable Van Duzen River which would be consistent with California's Public Trust Doctrine. In *Bess vs. County of Humboldt (1992)*, Footnote No. 3 explains that Civil Code sections 813 and 1009 were altered by statute in 1972 and that both permissive use and road maintenance were required for an implied dedication. But prior to 1972 only permissive use over a least a 5-year period was the rule. The Staff Report and submitted letters state that public use of Fisher Road prior to 1972 occurred on a regular basis for many years. The county should therefore assert an implied dedication of public use along the road's previous location which includes the gravel bar and river.

On page 3, under No. 2, the last bullet discusses restoration of the portion of road that washed out and the enormous cost it would entail to repair it. I agree, so why not work with the Patton's to obtain a deeded trail easement from the K-Rail Site to the gravel bar. The trail already exists...no maintenance required.

I suggest that the Board consider closing Fisher Road at night south of the white gate. By physically closing the road at night, most if not all the problems the Patton's mentioned related to littering and drug use would disappear. The Patton's could be in charge of opening and shutting the gate. The county would be in charge of the lock and keys. All appropriate emergency organizations would be issued a numbered key.

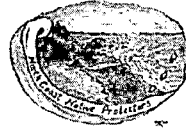
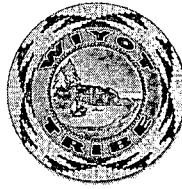

The commission points out that the Van Duzen River is both navigable and designated as "Wild and Scenic."

The proposed vacation would have eliminated the public's right to access and use the Van Duzen River from Fisher Road. Established historical use of this public road to access the river dates back to at least the 1930s. Because the Van Duzen River is a navigable waterway, the public has the right to use the river and the river bed up to the high-water mark for navigational, fishing, recreational, and other purposes. As established by the County's defense of public access rights in the 1992 case Bess v. County of Humboldt (3 Cal. App. 4th 1547), "a right-of-way to a river extends to the river throughout any changes in the river's course".

The undersigned organizations appreciate the efforts of the Humboldt Fish and Game Commission and strongly support maintaining public access to the Van Duzen via Fisher Road. Fisher Road has been in the public domain for nearly a century, and is a rare point of public access to both the Van Duzen river and the future Great Redwood Trail.

Thirty years ago Humboldt County fought and won in court to protect public river access at Odd Fellows Park Road, about a mile east of Fisher Road. We hope that today your board will make a similar decision.

The Humboldt Trails Council (HTC) would like to give input on the April 18th letter the board received from the Humboldt County Fish and Game Advisory Commission. The commission unanimously approved this letter advising the board of their concern regarding the recent attempt to vacate the southern portion of Fisher Road in Hydesville, and recommended securing public access on the road and to the river. We support their recommendation.

HTC is very interested in maintaining public access on Fisher Road and to the Van Duzen River. The Carlotta spur of the Great Redwood Trail passes through the property in question, and access to the river for the trail users is highly desirable. In general, there is little access for the public to the river along the first 12 miles of Highway 36; this is not the time to drop this one. Strong evidence of the public using this road to access the river exists, including county records that document maintenance of the road as far back as 1934.

The proposed vacation would have eliminated the public's right to access and use the Van Duzen River from Fisher Road. The public has the right to use the river and the river bed up to the high-water mark for navigational, fishing, recreational, and other purposes. This was established by the County's defense of public access rights in the 1992 case Bess v. County of Humboldt (3 Cal. App. 4th 1547), "a right-of-way to a river extends to the river throughout any changes in the river's course".

We urge you to secure and formalize continued public access to Fisher Road and the Van Duzen River. Thank you for your consideration of this issue.

RE: River Access – Van Duzen River via Fisher Road

I am a user of Fisher Road and have been using it since the 1940's. I have used the road for walking and now generally access the Van Duzen River at the end of Fisher Road by car. It is one of the most memorable locations from my childhood as I have been a frequent visitor to the Fishers ranch. My parents once lived on that property. I previously sent a letter further detailing my connections to this part of Humboldt County. I would not oppose this beautiful area being included on the Great Redwood Trail route, but only if vehicle access is concurrently maintained for public use. I strongly favor making access to the river at the end of Fisher Road a permanent public right by codifying public access legally and permanently.

On April 18th the Humboldt County Fish and Game Commission approved a letter to send to the Humboldt County Board of Supervisors advising the board of their concern in the recent attempt to vacate the southern portion of Fisher Road in Hydesville. The commission points out that the Van Duzen River is both navigable and designated as "Wild and Scenic." There is a lengthy history of public use on this road and to the river bar below it. The vacation would have eliminated the public's right to access and use of this navigable river. They referenced the public trust doctrine.

The commission recommends that the board pursue a "deeded" public right-of-way instead of the current status as an "implied common law dedication right-of-way." This will eliminate future attempts to have the county vacate the road. Furthermore, the commission also recommends that the Board of Supervisors pursue a prescriptive right-of-way to provide the public with permanent legal access from the end of the deeded right-of-way to the river.

I strongly support the advice of this board. This road has been in the public domain for many decades. We do not need to lose another access point to the river.

The commission also recommends that the Board of Supervisors pursue a prescriptive right-of-way to provide the public with permanent legal access from the end of the deeded right-of-way to the river. **I strongly support the advice of the commission.** This road has been in the public domain for many decades. We do not need to lose another access point to the river. I support the Carlotta Branch of the Great Redwood Trail. The greater good of the community should prevail over perceived inconvenience by private property owners.

When we lived in Fortuna, years ago, this access was important to us. But we have had similar issues in Trinidad with the Martin Creek trail which was closed for years due to private property owner’s perception that access to water by “regular people” were some sort of menace.
