

RESOLUTION NO. 223-59

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARCATA
ADOPTING THE FISCAL YEAR 2023/24 ANNUAL REPORT ON STORMWATER DRAINAGE
MAINTENANCE FEE AND DIRECTING THAT SAID FEE BE COLLECTED THROUGH THE
PROPERTY TAX ROLLS FOR FISCAL YEAR 2023/24**

WHEREAS, in 1993 the City of Arcata implemented a Stormwater Management Program in order to comply with Federal and State mandated requirements relating to the control of stormwater pollutants; and

WHEREAS, as part of the Stormwater Management Program and as authorized by California Health and Safety Code §5471, the City established a Stormwater Drainage Maintenance Fee, codified at Section 7995.01, et seq, of the Arcata Municipal Code which is assessed to all property owners to pay for the operation, maintenance, improvement and replacement of City stormwater drainage facilities, to reduce stormwater pollution, to collect and convey runoff, and to protect public safety; and

WHEREAS, Section 5473 of the California Health and Safety Code allows an entity to elect to have such charges collected on the tax roll in the same manner and as at the same time as its general taxes; and

WHEREAS, Staff have determined that a more efficient and cost effective method to collect this fee is to consolidate this billing with that of the County of Humboldt on its Secured Property Tax Bill; and

WHEREAS, Staff have prepared the Fiscal Year 2023/24 Stormwater Drainage Maintenance Fee Report (the “Annual Report”) for the imposition and collection of stormwater drainage maintenance fees,

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Arcata hereby elects to have the Stormwater Drainage Maintenance Fee charges collected on the tax roll in the same manner, by the same persons, and at the same time, together with and not separately from the general taxes, confirms the Fiscal Year 2023/24 Stormwater Drainage Maintenance Fee as set forth in the Annual Report attached hereto and incorporated herein, and directs the Finance Director to file the Annual Report with the County Auditor-Controller no later than August 10, 2023.

This Resolution shall be effective upon its adoption.
