WHEREAS, the Parties now wish to: (1) extend the term of the Agreement, and (2) update the Invoice template that was attached to the Agreement as Exhibit D.

NOW THEREFORE, the parties mutually agree as follows:

- 1. Section 2 TERM is amended to read as follows:
 - 2. TERM:

This Agreement shall be effective commencing July 1, 2021 upon execution by both parties and shall remain in full force and effect until December 31, 2023.

- 2. The Agreement is amended to delete Exhibit D Invoice and replace it in its entirety with the modified version of Exhibit D that is attached hereto and incorporated herein by reference as if set forth in full. The modified version of Exhibit D attached hereto shall supersede any and all prior versions thereof as of the effective date of this Third Amendment.
- 3. Except as modified herein, the Agreement, as amended, shall remain in full force and effect. In the event of a conflict between the provisions of this Third Amendment and the original Agreement or the First or Second Amendments, the provisions of this Third Amendment shall govern.
