RECOMMENDATION: It is recommended that the Board of Supervisors:

1. Approve the Honeydew Bridge (4C-055) on Mattole Road as the County's choice for the State's Bridge Replacement Program.
2. Approve the attached Resolution of Need for the Honeydew Bridge, as required by the California Transportation Commission.

DISCUSSION: The attached Caltrans letter was received and indicates that Humboldt County will be allowed one bridge from the attached list for replacement. It is staff's recommendation that the following bridge be selected as a bridge replacement candidate:

Honeydew Bridge (4C-055): This bridge is an old steel truss bridge adjacent to the Honeydew Store. It was originally constructed in 1920 and has served well, but is now showing definite signs of its age. Much of the bridge's support members are worn and in need of replacement.

In addition, the low clearance of the truss prevents our low-bed trucks from transporting equipment across the bridge. This limitation can become critical during severe storms when either or both of the Ettersburg/Honeydew or the Mattole Road are closed. If the bridge is replaced with a modern concrete structure, this will remove the restrictions to transporting equipment and greatly improve our access during critical winter storms.

As stated in the eligibility guidelines for the Bridge Replacement Program (HBRR):

"Bridges with an Average Daily Traffic less than 200 will not be eligible for HBRR funding unless the Local Agency obtains a legislative "Resolution of Need" as required by the California Transportation Commission (CTC) Resolution #G-94-14. The "Resolution of Need" must state that the bridge is:

- "1. Very significant to the local economy and/or,
- "2. Critically needed for emergency access and/or,
- "3. Required for school bus transportation and/or,
- "4. Required for some other stated specific significant local need.

"For each finding, the resolution shall state that there is no reasonable alternative route."

Staff believes that the replacement of this bridge is justified under Item 2, critically needed for emergency access. As discussed previously, this bridge becomes critically important when the other two access roads are impassable. This situation occurred during the 1995 winter storms and has been a historical problem in earlier disasters. Please find the attached "Resolution of Need" which includes the proper findings.

FINANCIAL IMPACT: The County will be required to match 20% of the bridge replacement cost. This match will come from Road Fund monies. Budget documentation will be submitted for the appropriate year of construction. No line expenditure is required for the current fiscal year.

OTHER AGENCY INVOLVEMENT: Caltrans

ALTERNATIVES TO STAFF RECOMMENDATIONS: The Board may decide not to approve the recommended bridge for replacement.

WHEREAS, the Board of Supervisors of Humboldt County wishes to replace said bridge under the Federal Highway Administration (FHWA) Bridge Replacement Program.

NOW, THEREFORE, the Board of Supervisors of the County of Humboldt resolves that:

1. Honeydew Bridge (4C-055) is critically needed for emergency vehicles access for local residents and for fire access to forested areas.
2. Honeydew Bridge (4C-055) is critically needed since there is no available detour nor alternate access route to serve the needs of existing residences.
3. Honeydew Bridge (4C-055) is significant to the local economy in that it provides access to important timber and agricultural lands.
4. Honeydew Bridge (4C-055) has restricted vertical clearance which prohibits the transport of critically-needed heavy equipment to repair and reopen roads during severe storms. The replacement of the bridge will alleviate this problem and improve our response time during emergencies.
