Hey Yung Mr. Yandell,

The applicant has requested a letter of support for the relocation of his cultivation site. The proposed move of the current cultivation sites onto one 2.4 acre timber conversion which is flat and hidden from view by a stand of trees, is of less concern to the Tribe, than the current locations. I recognize that growing on a flat space facilitates more effective management of the water usage and the remediation of the old sites will prevent sediment discharge and improve water quality. This move also minimizes the amount of land base used for cultivation. I also understand that part of the remediation plans are to remove all materials from the previous sites and to reseed them with local grasses. It is my understanding that the water for cultivation comes from deep ground water wells that are disconnected from surface waters. This letter should not be interpreted as an approval or concurrence of the cultural resource findings, or as deference to the permit review process, but only as consent to relocate grow area.
