DIRECTIONS

FROM HWY 101, EXIT AT FERNBRIDGE AND HEAD SOUTH. TURN RIGHT ONTO CA 211 TOWARDS FERNDALE. PASS THROUGH FERNDALE AND TURN RIGHT ON OCEAN AVE., THEN SHORTLY THEREAFTER, TURN LEFT ON TO WILDCAT/MATTOLE ROAD HEADING TOWARDS PETROLIA. CONTINUE FOR 30.7 MILES TO PETROLIA. FOLLOW THE MAIN ROAD (FRONT STREET) THROUGH TOWN AND HEAD RIGHT, ONTO MATTOLE RD. CONTINUE FOR 0.2 MILES, THEN TURN LEFT ONTO CHAMBERS RD. CONTINUE FOR ~0.6 MILES. PROJECT SITE WILL BE ON THE LEFT. THE ACCES DRIVE IS ON THE LEFT JUST BEFORE THE ROAD BEGINS TO DESCEND INTO THE EAST MILL CREEK DRAINAGE.

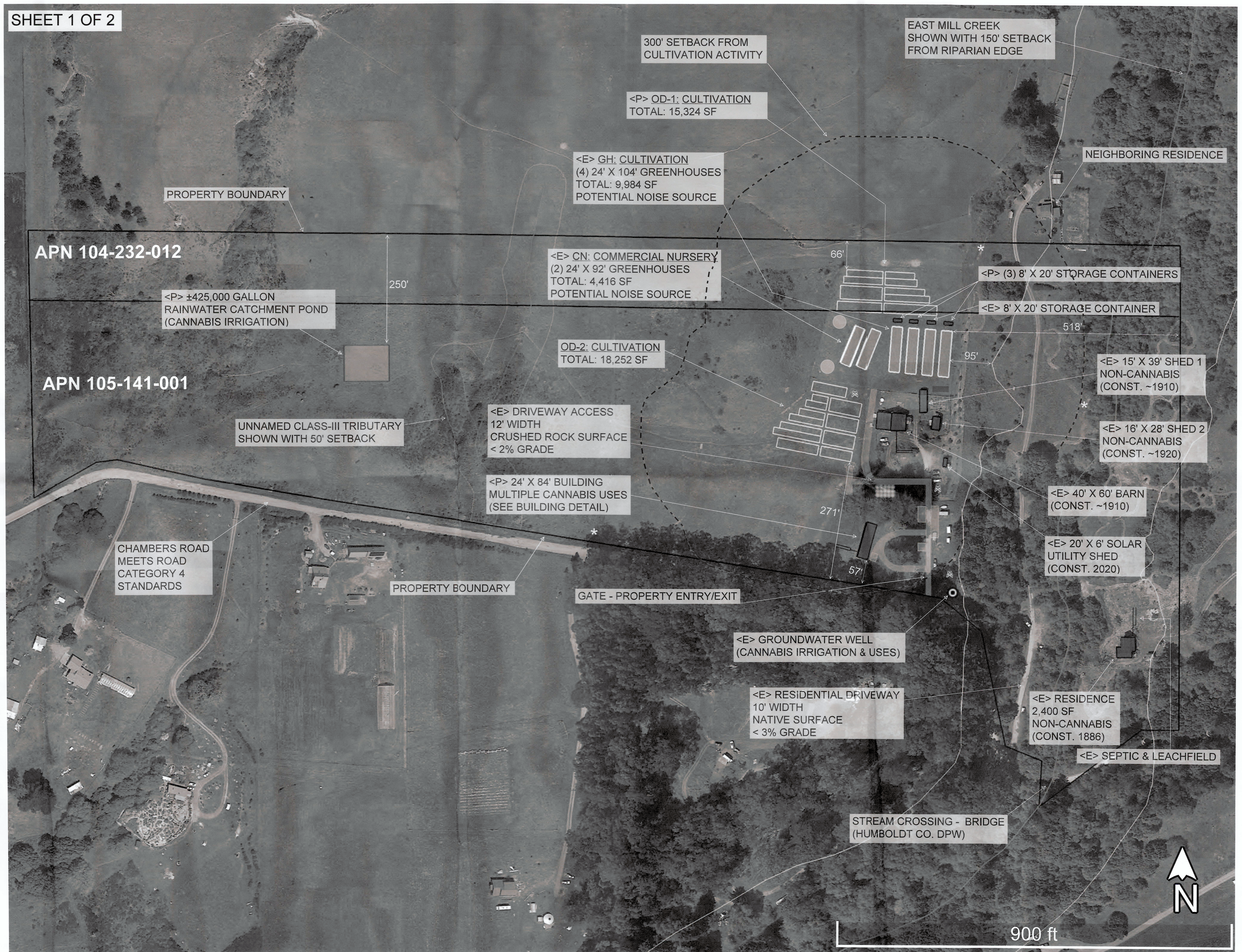
