FISHER ROAD TURNAROUND EASEMENT

The easement area situated in Township 2 North, Range 1 East, Humboldt Meridian, Section 21, in the County of Humboldt, State of California, described as follows:

COMMENCING at the Southeast corner of Parcel 2 as shown on Parcel Map No. 1535 recorded in Book 13 of Parcel Maps, Page 80, Humboldt County Records:

THENCE North 89 degrees 50 minutes 30 seconds West, 40.00 feet more or less along the South line of said Parcel 2 to the center of the traveled way of Fisher Road as it existed on September 22, 2022 and the TRUE POINT OF BEGINNING;

THENCE South 89 degrees 50 minutes 30 seconds East along said South line of said Parcel 2, 10.00 feet;

THENCE South 00 degrees 09 minutes 30 seconds West, 85.00 feet;

THENCE North 89 degrees 50 minutes 30 seconds West, 20.00 feet to the beginning of a non-tangent curve to the left, concave to the Southwest, having a radius of 50.00 feet and a radial bearing of South 61 degrees 35 minutes 18 seconds West;

THENCE along said curve to the left through a central angle of 32 degrees 51 minutes 36 seconds an arc length of 28.68 feet;

THENCE North 00 degrees 09 minutes 30 seconds East, 20.00 feet to the beginning of a non-tangent curve to the left, concave to the Northwest, having a radius of 50.00 feet and a radial bearing of North 28 degrees 24 minutes 42 seconds West;


THENCE along said curve to the left through a central angle of 32 degrees 51 minutes 36 seconds an arc length of 28.68 feet;

Basis of Bearings is Parcel Map No. 1535 recorded in Book 13 of Parcel Maps, Page 80, Humboldt County Records.

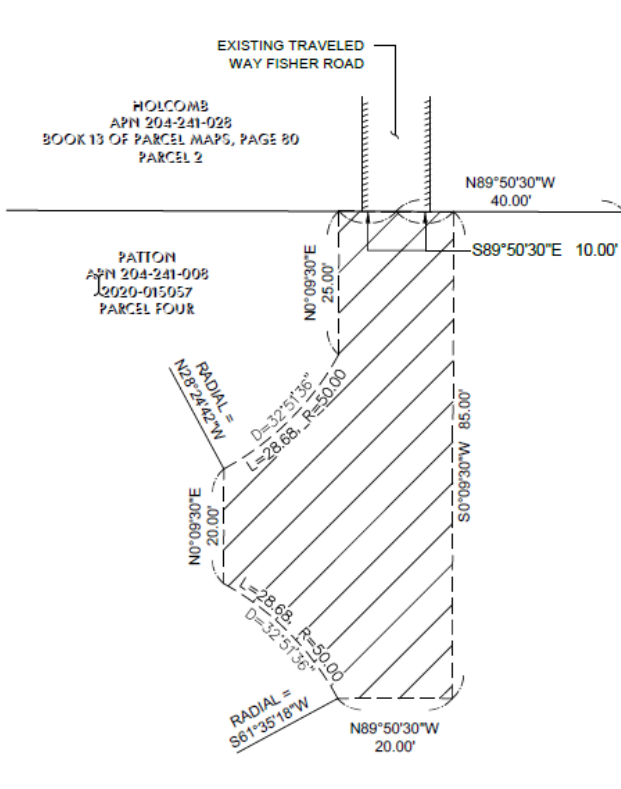

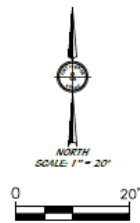
**EXHIBIT B
