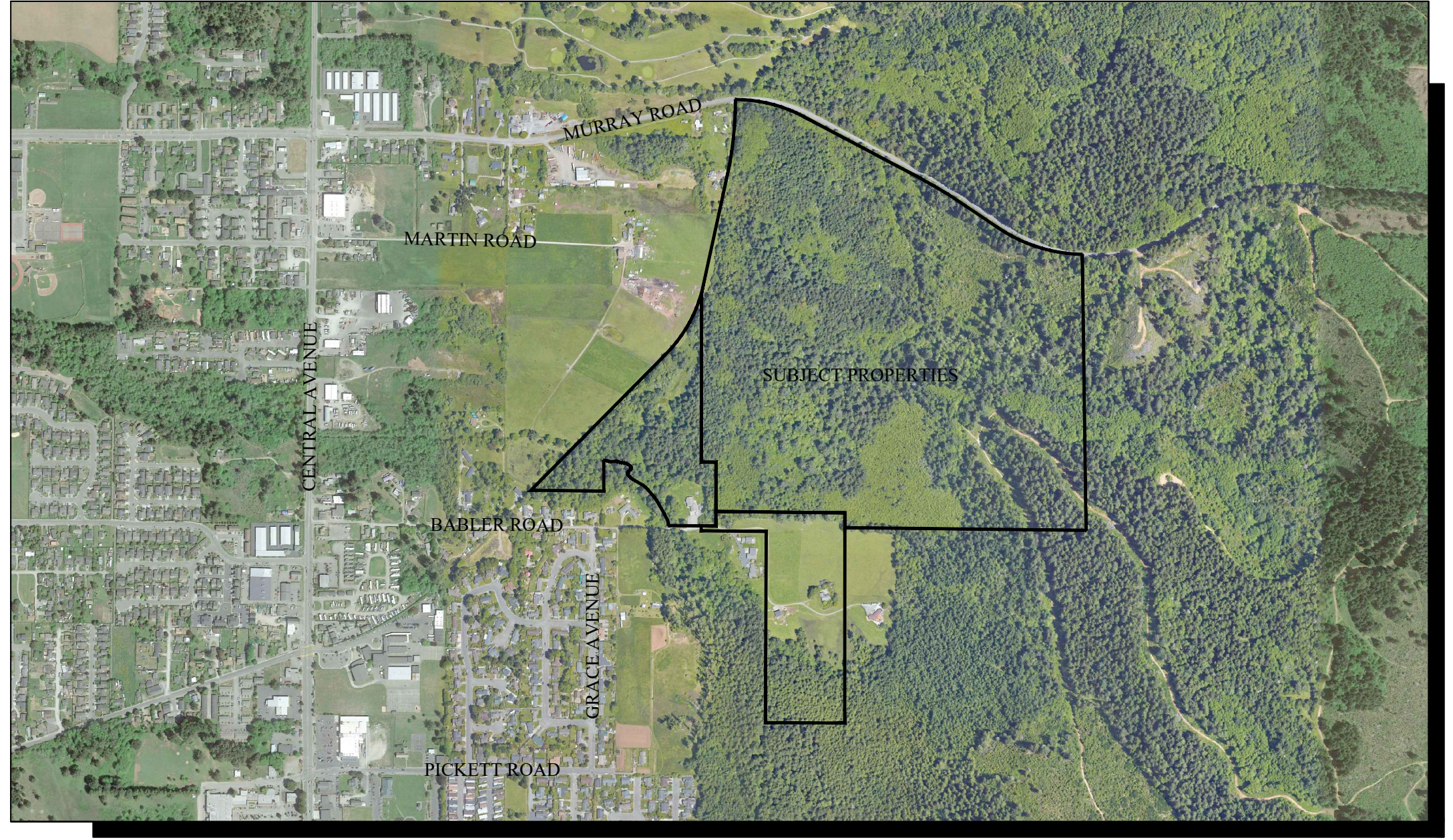
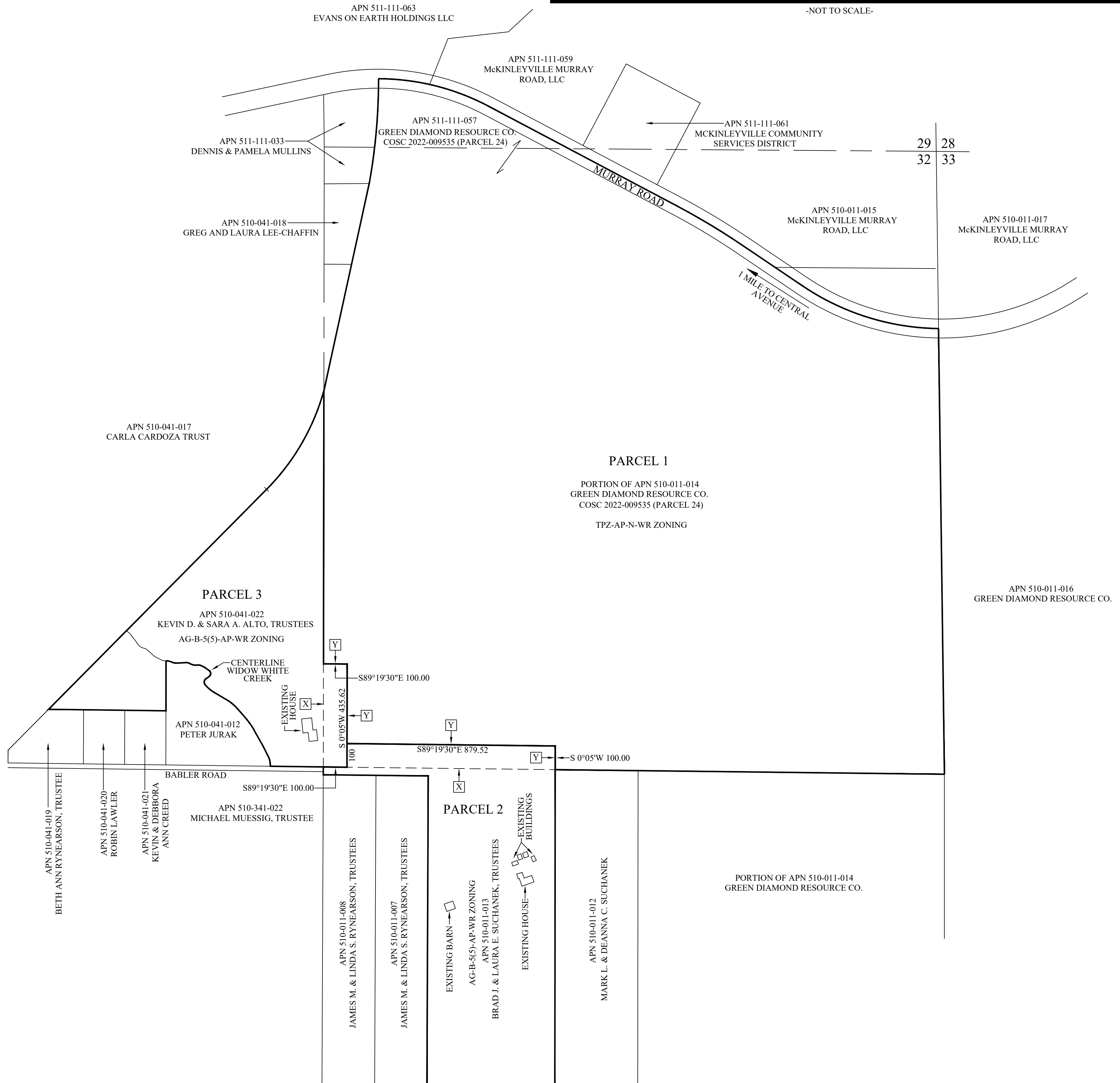


VICINITY MAP
