RESOLUTION 234-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARCATA, ESTABLISHING SCHOOL ZONE SPEED LIMITS ON CITY STREETS AND ROADS

WHEREAS, the California Vehicle Code Section 22352 establishes a "prima facie" speed limit of twenty-five miles per hour "When approaching or passing a school building or the grounds thereof, contiguous to a highway and posted with a standard 'SCHOOL' warning sign, while children are going to or leaving the school either during school hours or during the noon recess period"; and

WHEREAS, the Safer School Zone Act, also known as Assembly Bill 321, is a state law that went into effect in 2008 and allows cities and counties to expand 25-mile-per-hour school zones and reduce speeds immediately around schools to 15 miles per hour; and

WHEREAS, the Assembly Bill 43, which went into effect in 2022, allows the City to reduce the posted speed limits in School Zones, Senior Center, and Business Activity District to as low as 15 mph without requiring an engineering and traffic surveys; and

WHEREAS, the prima facie or maximum speed limits established pursuant to this resolution shall be effective when appropriate signs giving notice thereof are erected upon the affected streets.

NOW THEREFORE, BE IT RESOLVED that the City Council of the City of Arcata hereby establishes that the school zone speed limits on those specific streets and roads as shown in **Exhibit A**, attached hereto and incorporated herein, shall become the school zone speed limits for those specific City streets and roads.

This Resolution shall be effective upon its adoption.
