### **Project Justification:**

Trinidad Scenic Drive is the old State Highway 101 constructed in the 1920's that was relinquished to the County when Highway 101 was realigned in the 1960's. The Coastal route serves as access to many residents, the Trinidad Rancheria, many public beaches and the Community of Trinidad. The road suffers from reoccurring storm damage and winter ocean conditions. The road is an economic driver for the local area.

### **Project Description:**

There has not been a comprehensive plan for the road since it's initial construction as a State Highway in the 1920's. Due to the County's lack of resources, work on this road has been segmental and mainly reactive to natural disasters other than normal routing maintenance such as grading, mowing and pothole filling. The road is a destination for our of area and local tourists, access to residents and the Trinidad Rancheria. A long term plan for the road will allow the County to pursue construction funding for a more resilient and sustainable road. The funds will be expended on the development of a long term plan to repair the road.
