County shall pay, and Contractor shall accept Contractor's Bid Prices, as shown on EXHIBIT "A" attached hereto and made a part hereof, as full compensation for furnishing all materials and for doing all the work contemplated and embraced in this Agreement; also for all loss or damage, arising out of the work aforesaid, or from the actions of the elements, or from any unforeseen difficulties or obstructions which may arise or be encountered in the prosecution of the work until its acceptance by County, and for all risks of every description connected with the work; also for all expenses incurred by or in consequence of the suspension or discontinuance of the work and for well and faithfully completing the work, and the whole thereof, in the manner and according to the Plans and Specifications, and the requirements of the Engineer.

Under no circumstances shall the CONTRACTOR enter upon the site of work until receipt of the "Notice to Proceed", or unless so authorized in writing by the COUNTY.

Section 5 - TIME OF COMPLETION

The work called for in this Agreement shall be commenced within fifteen (15) of	lays o	f receipt of Notice to
Proceed by COUNTY and shall be fully completed within a period of	100	working days
beginning on the fifteenth calendar day after the date of said approval of contract.		

Section 6 - PREVAILING WAGE

Copies of the prevailing wage rates of per diem wages are on file in the Humboldt County Public Works office at 1106 Second Street, Eureka, California and are available to any interested person on request.

Section 7 - WORKERS' COMPENSATION

By my signature hereunder, as CONTRACTOR, I certify that I am aware of the provisions of Section 3700 of the Labor Code which requires every employer to be insured against liability for Workers' Compensation or to undertake self insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of the work of this contract.

Section 8 - COMPLIANCE WITH LAWS

The Special Provisions and Plans are hereby modified in accordance with the following:

PROJECT SPECIAL PROVISIONS

1. Special Provisions Page 35, Bid Form (Exhibit A), shall be replaced by the attached Addendum No. 1 Bid Form (Exhibit A).

PROJECT PLANS

- 2. Sheets 12, 13, and 15, Quantity Tables, are revised to correct quantities for pavement markings and detectable warning surfaces.
- 3. Sheets 57-59, Intersection Striping, are revised to correct quantities, clarify the pavement marking work proposed at individual sites, and correct the description of work from "Striping" to "Marking."

CONTRACTOR QUESTIONS

1. Will bid items be added for Steel Channel Arch Drain per LF and/or Gutter Cover Plate Assembly per LF?

No additional bid items are included for replacing existing drains at 5 of the 12 blended transition curb ramps. Costs associated with reconstructing these drains shall be included in the related bid item(s).

- 2. Confirm the amount of striping to be removed. Plan Sheets 57-59 have the removal amount measured in Lineal Feet; however, removal of pavement markings is usually measured in Square Feet. Note that removal of striping is more expensive than placement of striping. Due to the amount of removal, it may be advisable to add a separate bid item for the removal.
 - Revised Plan Sheets 57-59 are attached to correct quantities, clarify the pavement marking work proposed at individual sites, and correct the description of work from "Striping" to "Marking." A separate bid item for removal of thermoplastic pavement marking is included in Addendum No. 1 Bid Form (Exhibit A) to provide for aligning the crosswalk with the new curb ramp at the intersection of Central Avenue and Anna Sparks Way (CR 3-1-60). Pavement markings at all other locations are expected be removed in the process of constructing the curb ramps.
- 3. Confirm amount of striping to be placed. The amount listed appears low based on the Lineal Feet measurements and crosswalk types shown in the plans.
 - No pavement striping is anticipated on this project. Revised quantities for Pavement Markings are included in the attached Plan Sheets 12, 13, 15, and 57-59 and Addendum No. 1 Bid Form (Exhibit A).
- 4. For Bid Item No. 22, Install Detectable Warning Surface, is the unit "Each" quantified as 12 SF for a 3'x4' mat?
 - The unit "Each" refers to a continuous detectable warning surface to be installed at each location. Revised quantities for Detectable Warning Surface are included in the attached Plan Sheets 12-13 and Addendum No. 1 Bid Form (Exhibit A). The detectable warning surface is 12 SF (3'x4') at each of the locations listed on Plan Sheets 14-15.
- 5. The number of designs for complete curb ramp replacements included in the plans (42 EA) does not match the bid quantities for complete curb ramp replacements (72 EA).
 - The 42 curb ramps detailed in the project plans required specific design and staking to meet all accessibility requirements. The thirty curb ramps listed as replacements in the quantity tables on Sheets 14-15 can be constructed based on standard details.
