Ayukii (hello) Mr. Ford,

The Karuk Tribe writes to you regarding its cultural resources inspection for commercial cannabis cultivation application (APPS # 11544). The proposed cultivation site falls within a Karuk Area of Traditional Tribal Cultural Affiliation and as a result requires a cultural resource inspection. This inspection is in accordance with Humboldt County's Commercial Cannabis Land Use Ordinance ("Cannabis Ordinance") which provides for government-to-government consultation with federally recognized tribes over cannabis operations which impact their tribal cultural resources. As a result of coordination meetings between the Karuk Tribe and Humboldt County Planning and Building Staff, Karuk tribal representatives explained that the tribe would have a process for entering into agreements with applicants to perform cultural resource inspections of proposed cannabis cultivation operations that are within a Karuk Area of Traditional Tribal Cultural Affiliation to ensure the protection of Karuk cultural resources.

Consistent with this tribal process, an agreement was signed on (\_\_\_\_\_) between the Karuk Tribe and the Applicant to conduct this inspection. An inspection was completed by tribal cultural monitors on (\_\_\_\_\_) During this inspection we determined that the cultivation area was less than 600 feet from a Karuk Cultural Resource. The applicant voluntarily entered into a mitigation plan with the Tribe which meets the intent of Section 55.4.6.4.4 (c) of the Cannabis Ordinance.

Consistent with this tribal process, an agreement was signed on (\_\_\_\_\_) between the Karuk Tribe and the Applicant to conduct this inspection. An inspection was completed by tribal cultural monitors on (\_\_\_\_\_) During this inspection we determined that the cultivation area was at least 600 feet from a Karuk Cultural Resource as required by the Section 55.4.6.4.4 (c) of the Cannabis Ordinance. However, we found that the cultivation site will have an effect on certain Karuk Cultural Resources. As a result, we request that a cannabis permit be denied unless the applicant voluntarily enters into a mitigation plan with the Tribe.

Consistent with this tribal process, an agreement was signed on (\_\_\_\_\_) between the Karuk Tribe and the Applicant to conduct this inspection. An inspection was completed by tribal cultural monitors on (\_\_\_\_). During this inspection we determined that the cultivation area was less than 1000 feet from a Karuk Ceremonial Site which violates Section 55.4.6.4.4 (d) of the Cannabis Ordinance. As a result, we request that a cannabis permit be denied unless the applicant voluntarily enters into a mitigation plan with the Tribe.

Consistent with this tribal process, an agreement was signed on (\_\_\_\_\_) between the Karuk Tribe and the Applicant to conduct this inspection. An inspection was completed by tribal cultural monitors on (\_\_\_\_). During this inspection we determined that the cultivation area was less than 1000 feet from a Karuk Ceremonial Site which violates Section 55.4.6.4.4 (d) of the Cannabis Ordinance. We request that a cannabis permit be denied as there is no suitable mitigation measure at this time.

The proposed cannabis cultivation operations are within the Karuk Area of Traditional Tribal Cultural Affiliation. We have determined that the cultivation area was at least 600 feet from a Karuk Cultural Resource per Section 55.4.6.4.4 (c) of the Cannabis Ordinance. Negative impacts of the proposed operation upon cultural resources are occurring and will continue to occur; as a result, the cannabis permit must be denied.

Consistent with this tribal process, an agreement was signed on (\_\_\_\_\_) between the Karuk Tribe and the Applicant to conduct this inspection. An inspection was completed by tribal cultural monitors on (\_\_\_\_). During this inspection we determined that the cultivation area was more than 600 feet from a Karuk Cultural Resource and had no discernable impact on cultural resources.

In conclusion, we request that the County comply with applicable federal and state law regarding the protection of tribal cultural resources, and the Cannabis Ordinance, and implement the Karuk recommendations contained in this letter regarding APPS# 11544. The Yurok Tribe recommends denial of PLN-1154-CUP. Please find a list of justifications for this recommendation below.

- The boundaries of the Kewet Ceremonial District, a cultural resource recognized by both Humboldt County and the Yurok Tribe, extend hundreds of feet into parcel 530-151-005. While the proposed grow area is outside of the District, its proximity to the District would be detrimental to nearby Yurok cultural practices. Furthermore, the Yurok Tribes cultural use of the Bee Mountain area extend well beyond the boundaries of the Kewet District and considers the entire region to be sacred.
- The Yurok Tribe has determined that the biological assessment associated with this project requires more scrutiny.
- The proposed project would impose a heavy environmental burden. The Bluff Creek Watershed has already been negatively impacted by a history of illegal cannabis cultivation and, as is the case with the Yurok Reservation in general, it remains stressed by ongoing drought. The State of California's drought emergency declaration stands within the Klamath River Watershed.
- The project would source water from a water storage pond that was erroneously permitted by Humboldt County. In the Tribe's opinion, this pond is noncompliant, a threat to the local ecosystem, and unallowable.
- The grow area was also cleared without a Timber Harvest Plan and associated, required, permits.
- The history of non-compliance on this parcel disqualifies the applicant from being a trusted, permittable member of the Weitchpec area community.
- The Tribe is also aware of the criminal history surrounding this site. There is no reason to believe such activities would not persist should this application be approved.

### **PLN-11544-CUP (APN: 530-151-005) Project Description**

An application for a Conditional Use Permit for 43,560 square feet (SF) of existing outdoor cannabis cultivation, 29,500 square feet of existing onsite and up to 14,060 of existing cultivation being relocated from a parcel immediately south. Water for irrigation is sourced from a rainwater catchment pond. Processing, including drying and trimming, occurs in an existing on-site facility. Electricity is sourced from generator power.

### **CDFW COMMENTS:**

Thank you for referring this application to the California Department of Fish and Wildlife (CDFW) for review and comment. The following history and comments on the proposed project are intended to provide background and to assist the Lead Agency in making informed decisions on the proposed project PLN-11544-CUP. The following comments shall supersede prior comments submitted by CDFW regarding PLN-11544-CUP. CDFW requests that all comments are incorporated in the final Humboldt County Staff Report. **Note, CDFW comments do not constitute recommendation for project approval.**

### **Comments:**

- In September 2017, CDFW staff visited the application site and thoroughly walked the parcel noting all existing cannabis cultivation. Following this site visit, CDFW staff reviewed aerial imagery and noted significant unauthorized cultivation expansion and timber conversion after 2016 on Timberland Production Zone (TPZ) land. Cultivation present in 2015 was approximately 23,500 sq ft. In 2018 it was noted that approximately 80,500 sq ft (~1.9 acres) of additional unauthorized timber conversion occurred on Timber Production Zone (TPZ) for the purposed of cannabis cultivation expansion. CDFW requests that the conversion site is evaluated by a Registered Professional Forester and be restocked

at a 3:1 ratio to mitigate for the unauthorized ~1.9 acres of timber conversion that occurred sometime after 2016.

- In the summer of 2019, the applicant engaged in significant unpermitted grading and habitat conversion for the unauthorized construction of an approximately 700,000-gallon cannabis irrigation pond. This conversion occurred without applicable County and State permits and without the benefit of environmental review. Unmanaged rainwater catchment ponds can provide habitat for non-native and invasive species. CDFW requests that the applicant is required to submit a Restoration Plan to remove the rainwater catchment pond, restock the converted area at a 3:1 ratio to restore the pond site, to the extent feasible, to pre-existing conditions.
- On June 28, 2021, CDFW issued a Final Lake or Streambed Alteration Agreement (LSAA, EPIMS-HUM-20833-R1) to the applicant. The LSAA includes one encroachment for water diversion from a spring, limited to domestic use.
- The proposed project has the potential to significantly impact special status plant species including, but not limited to, the robust false lupine (*Thermopsis robusta*), and the white-flowered rein orchid (*Piperia candida*). Additionally, the proposed project site contains ultramafic “serpentine” soils. Serpentine soils are uncommon (1% in California) but support more than 13% of the state’s endemic plant species. Serpentine soils in this bioregion have been significantly impacted by historical and/or modern anthropogenic land use practices. The Biological Assessment completed for the proposed project by Leopardo Wildlife Associates, states that, “...potential impacts to sensitive botanical communities can reasonably be dismissed...” CDFW disagrees with the conclusions made in the Biological Assessment. Due to the presence of habitat, known species occurrences in the area and that no botanical surveys have been completed, the proposed project has the potential to significantly impact sensitive plant species.
- The proposed project has the potential to significantly impact special status animal species including, but not limited to, the Northern Spotted Owl (*Strix occidentalis caurina*; NSO), the Marbled Murrelet (*Brachyramphus marmoratus*), the Humboldt Marten (*Martes caurina humboldtensis*), and the California Condor (*Gymnogyps californianus*). Designated critical habitat for NSO, the Marbled Murrelet, and habitat for the Humboldt Marten is adjacent to the project sites. There are also at least two known NSO Activity Centers that occur within one mile of the cultivation sites (CDFW 2023). Additionally, the proposed site is located within the experimental range of the California Condor. The Biological Assessment completed by Leopardo Wildlife Associates, states that, “... no plant or animal community potentially impacted by proposed cannabis cultivation activities in manner that would be CEQA significant.” CDFW disagrees with the conclusions made in the Biological Assessment. Due to the project location, the presence of habitat and known occurrences of animal species in the area, the proposed project has the potential to significantly impact special status animal species.
- The proposed project would require the reduction of the 600 ft. setback from United States Forest Service (USFS) ownership. The proposed project is adjacent to designated critical habitat for the NSO and the Marbled Murrelet on USFS ownership. Reducing the 600 ft. setback has the potential to impact sensitive species such as the NSO, the Marbled Murrelet, and the Humboldt Marten.
- To prevent ongoing impacts to sensitive species and their habitats, including potential take of State and federally listed species, CDFW recommends that PLN-11544-CUP be brought to decision, that denial be recommended, and that remediation of these sites be required.
