**AMENDING SECTION 311-7 OF THE HUMBOLDT COUNTY CODE  
BY REZONING PROPERTY IN THE BRICELAND AREA  
[PLN-14387-LLA (CAROLAN)]**

**The Board of Supervisors of the County of Humboldt ordains as follows:**

SECTION 1. ZONE AMENDMENT. Section 311-7 of the Humboldt County Code is hereby amended by rezoning lands in the Briceland area, through immediate conversion approximately 4.8 acres of Timberland Production Zone (TPZ) into Forestry Recreation with a 40-acre minimum parcel size (FR-B-5(40)), approximately 4.8 acres of Unclassified (U) into Timberland Production Zone and approximately 79 acres of Unclassified (U) into Forestry Recreation with a 40-acre minimum parcel size (FR-B-5(40)).

The area described in Exhibit A is also shown on the Humboldt County Zoning Maps [N-46] and on the map attached as Exhibit B.

SECTION 2. EFFECTIVE DATE. This ordinance shall become effective thirty (30) days after the date of its passage.

Lands to be rezoned from Unclassified (U) to Timberland Production Zone (TPZ)

thence South 87 degrees 51 minutes 08 seconds West, 890.00 feet to the West line of said East Half of the Northwest Quarter of said Section 12;  
thence North 01 degree 04 minutes 07 seconds West, along said line, 210.80 feet, more or less, to the POINT OF BEGINNING.

Lands to be rezoned from Unclassified to Forestry Recreation with a 40-acre minimum  
parcel size (FR-B-5(40))

The East Half of the Northwest Quarter of Section 12, Township 4 South, Range 2  
East, Humboldt Meridian.

EXCEPTING THERFROM the following described parcel:

BEGINNING at the Northwest corner of the East Half of the Northwest Quarter of Section 12, Township 4 South, Range 2 East, Humboldt Meridian;  
thence North 87 degrees 51 minutes 08 seconds East, along the North line of said East Half of the Northwest Quarter, 1232.76 feet;  
thence South 35 degrees 54 minutes 34 seconds West, 425.90 feet;  
thence North 36 degrees 12 minutes 33 seconds West, 150.39 feet;  
thence South 87 degrees 51 minutes 08 seconds West, 890.00 feet to the West line of said East Half of the Northwest Quarter of said Section 12;  
thence North 01 degree 04 minutes 07 seconds West, along said line, 210.80 feet, more or less, to the POINT OF BEGINNING.

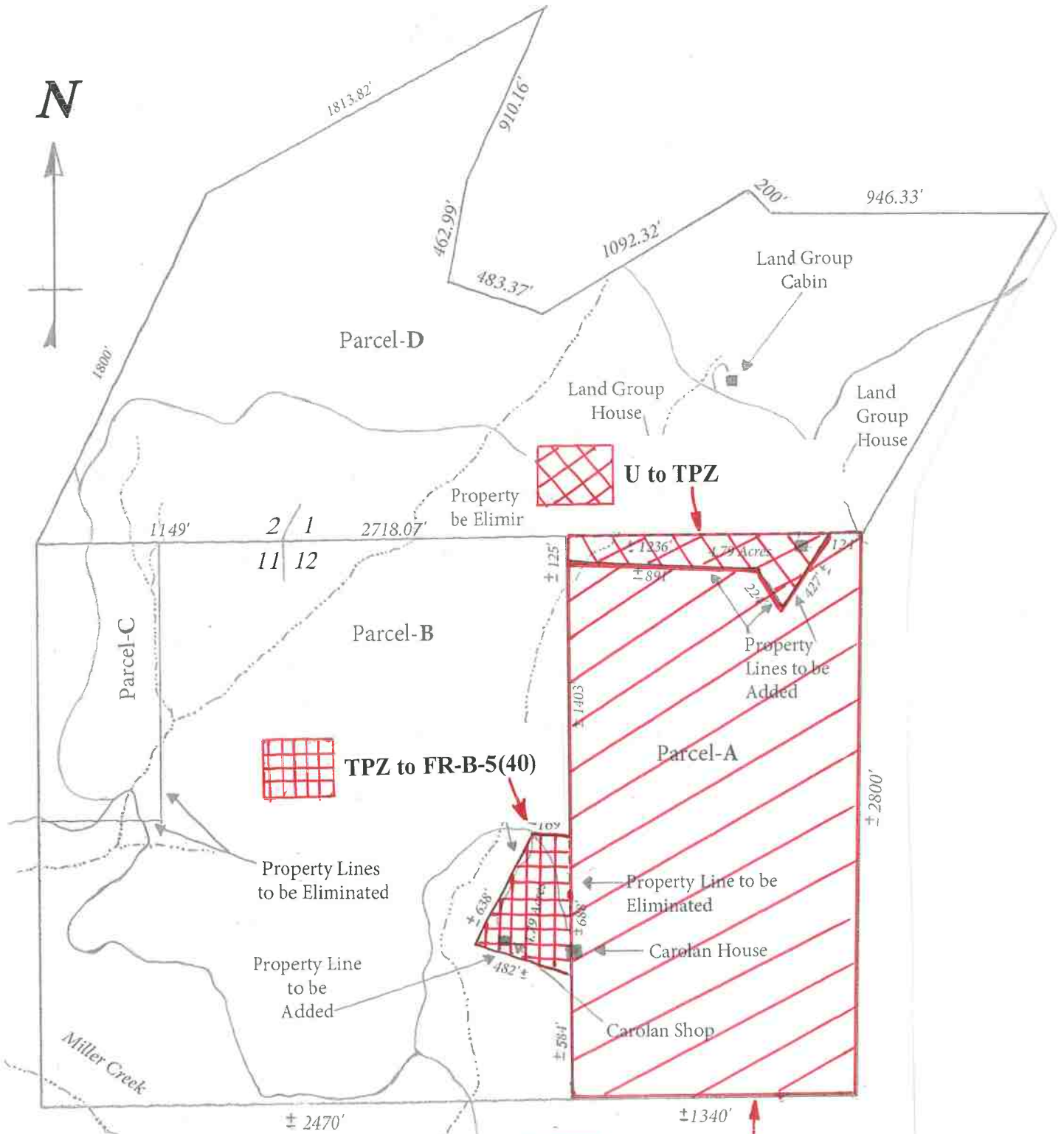

Lands to be rezoned from Timberland Production Zone (TPZ) to Forestry Recreation  
with a 40-acre minimum parcel size (FR-B-5(40))

BEGINNING at a point on the West line of the East Half of the Northwest Quarter of Section 12, Township 4 South, Range 2 East, Humboldt Meridian, 547.49 feet Northerly thereon from the Southwest corner of said East Half;  
thence North 72 degrees 16 minutes 33 seconds West, 530.72 feet;  
thence North 25 degrees 45 minutes 41 seconds East, 678.07 feet;  
thence North 88 degrees 55 minutes 53 seconds East, 196.39 feet, more or less, to the West line of said East Half;  
thence South 01 degrees 04 minutes 07 seconds East, along said line, 776.04 feet to the POINT OF BEGINNING.

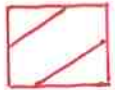
# Exhibit B Map
