Dear Mr. Johnston,

On behalf of Open Door Community Health Centers, I am pleased to write this letter in support of the We Are Up community project planned for McKinleyville. Open Door is very aware of the impact that safe, affordable housing has on the health of our patients and the community in general. We believe that housing is health. Access to safe, affordable housing is a key component to the overall health of our community.

There is a great need for We Are Up in our community because it addresses the lack of housing and the need for community for some of Humboldt County's most vulnerable populations. The groups that would benefit from We Are Up include adults under 65 with a disability, who make up 13.2% of Humboldt County's population, and seniors, comprising 19.2% of our population. These rates are higher than the national averages, which are 8.7% and 16.8%, respectively (Census 2020).

McKinleyville has no supportive housing for adults with disabilities. Humboldt County, with a population density of 38 people per square mile, has few (Census 2020). We Are Up aims to change this by developing an inclusive, intergenerational residential community with economic development and supports (job skills training, employment, and economic enterprise) for adults on the autism spectrum and those with physical, intellectual and/or developmental disabilities and for people without disabilities, including seniors, students pursuing social work, environmental, and health care studies, and temporary or relocating medical staff. By integrating people of different abilities, ages, socioeconomic backgrounds and interests, We Are Up will create a diverse and thriving community.

In addition to housing, the We Are Up Project offers a range of other benefits including a large community center, a commercial greenhouse, a community kitchen, and an orchard to promote farm-to-table food production. The farm and gardens will provide not only access to food but healthy activity and potential sources of income. The site's close proximity to grocery, health care, banking, bus line, and many other needs of daily life will lessen miles driven. Leaving two thirds of the land undeveloped allows access to nature, promotes land conservation, and allows space for continuing the historic agricultural uses of the site. We strongly support this diverse offering of benefits to the community.

I am writing this letter in support of HCAOG's proposed 2022 Regional Early Action Planning Grant to Improve Transportation and Housing Choices in McKinleyville.

HCAOG, Humboldt Transit Authority, and the non-profit We Are Up have partnered and are seeking to lay groundwork for transforming existing development patterns in McKinleyville towards mode shift, infill development, and affirmatively furthering fair housing outcomes by expanding transit and providing integrated housing opportunities for people with disabilities, seniors, and full-time students.

McKinleyville is among the County's fastest growing areas and the County is working on several planning efforts to promote infill, reduce sprawl and create transportation choices for existing and future residences. Among these efforts are the McKinleyville Town Center Master Plan and the McKinleyville Multimodal Connections project. The HCAOG project compliments these efforts.

The HCAOG proposal combines two much needed innovations for our County. The We Are Up project would be the first housing development to support integrated housing opportunities for people with disabilities, seniors, college students, and visiting medical professionals. Support for the We Are Up project's predevelopment costs will fund what is often the most precarious step in the development process and accelerate housing on the site. Although in an infill location, the parcel was not included in the County's Housing Element land inventory due to site constraints. With We Are Up's vision and creative approach, a 50-unit development is proposed.

The on-demand micro transit system will also be a first for the Humboldt region. Success of these programs in other rural and semi-rural areas is encouraging and the potential for replicating the project to other areas of the County will aid the County in limiting car dependency of future growth.


The Humboldt Area Foundation & Wild Rivers Community Foundation serves Humboldt, Trinity, and Del Norte counties, in California, and Curry County in Southern Oregon. This project aligns with our strategic goals for a Thriving, Just, Healthy and Equitable Region: specifically addressing priority areas of just economic development and thriving youth and communities: www.hafoundation.org

Although McKinleyville is rural Humboldt's largest and fastest-growing unincorporated community, it has only two public transportation options—the fixed-route Redwood Transit Services (RTS) system operated by the Humboldt Transit Authority (HTA), and Dial-A-Ride, paratransit, a shared van system, for seniors and people with disabilities living within a one-and-a-half-mile radius of the RTS route. With a REAP 2.0 grant, HCAOG's mobility on-demand, micro-transit program will be a lower-emission alternative to private vehicle commutes.

McKinleyville has no supportive housing for adults with disabilities. Humboldt County with a population density of 38 people per square mile, has few. With a REAP 2.0 grant, HCAOG and partners We Are Up, and HTA will implement an approach to disrupt current, car-centric, development in McKinleyville by creating accessible, transit options in conjunction with higher density, in-fill, small footprint housing. This grant supports We Are Up in developing an inclusive, intergenerational residential community with economic development and supports (job skills training, employment, and economic enterprise for adults on the autism spectrum and those with physical, intellectual and/or developmental disabilities) for people with and without disabilities, including seniors comprising 19.2% of Humboldt's population (Census 2020).

This pilot housing and transit collaboration can be replicated in rural communities with population densities too low to support a traditional, fixed-route transit system and with a high

Dear Grant Review Committee Members.

I am writing in strong support of the innovative proposal from HCAOG and We Are Up for REAP 2.0 grant funding.

This type of public-private partnership is exactly what is needed to solve some of the most impenetrable problems of the region and may well serve as a model for other parts of the state as well. With one grant, these innovators are securing space for infill housing for some of the most marginalized in our community and providing transportation solutions for the fastest growing community in the county.

The We Are Up mission, to build an inclusive, intergenerational community that will offer secure housing, income opportunities and mutual support systems for adults with and without disabilities is well underway. The non-profit has secured a 15-acre site that is a prime location for infill housing because it is within walking distance of a grocery store, health care facilities, a pharmacy, a bank, entertainment venues, a health club, a bus line, designated recreational trails, and other services.

Following community input, We Are Up has prepared an architect-drawn site plan for 50 units of housing, and will submit their CEQA documents before year end. Their design, successful in Europe but not seen in the US, is one where all residents -- adults with and without disabilities -- will contribute to the community at large through a welcoming community center, farm-to-table food production and conservation. Residents will no longer be isolated but able to participate in the community and contribute. They will have the opportunity to participate in meaningful employment and community engagement. The REAP 2.0 grant sought by We Are Up would fund the pre-development phase of We Are Up's innovative housing model that will be the first community of its kind in the nation.

The REAP grant will also support transforming transit choices throughout McKinleyville by piloting a program for on-demand microtransit. This component of the project will reroute the development trends in the County's largest and fastest-growing unincorporated community, which struggles with the legacy of car-centric development and the resulting sprawl. By funding microtransit options in McKinleyville, this grant will enable affordable, low-carbon transportation options that will connect to the local bus service and increase public transportation options.

I encourage you to support HCAOG and We Are Up as they leverage public and private support to improve transit and housing options for McKinleyville residents. These services will not only improve transportation options to reduce vehicle emissions but will also help fund the development of much-needed infill housing for people with autism or other disabilities in Humboldt County.

The Coalition for Responsible Transportation Priorities (CRTP) is a nonprofit organization based in Humboldt County whose mission is to promote transportation solutions that protect and support a healthy environment, healthy people, healthy communities and a healthy economy on California's North Coast. We have nearly 700 members and supporters throughout the region, many of them in McKinleyville.

McKinleyville is our area's third largest community, but one that has historically suffered from a sprawling development pattern with few transportation options beyond the personal automobile. CRTP is a current stakeholder in the McKinleyville Multimodal Connections Project, a state-funded planning process to advance safe active transportation options, as well as the county-run McKinleyville Town Center planning process, which seeks to encourage centrally located denser pedestrian and transit-oriented infill development. We also partnered with the Western Transportation Institute and your organization, the Humboldt County Association of Governments (HCAOG), in the McKinleyville Transit Study, which concluded in 2021 and recommended implementing an on-demand microtransit system in the community.

CRTP is extremely excited to support HCAOG's REAP 2.0 application for the Improving Transportation and Housing Choice in McKinleyville project. This project would both implement the vision of the McKinleyville Transit Study for on-demand microtransit and support the development of a higher density inclusive housing project called We Are Up in the core area of McKinleyville.

The microtransit component of this project will vastly improve affordable, low-carbon transportation options in McKinleyville and, by connecting to the regional fixed-route transit system, in the region as a whole. The infill housing component of the project will provide much-needed homes for people with autism and other disabilities within walking distance of jobs,

Many of our students and faculty reside in McKinleyville; thus, we have a keen interest in improving their housing and transit options.

In the past year, We Are Up has accomplished a tremendous amount to reach its goals, without the benefit of a single paid staff member.

I was there at my grandson Max's birth and again a few months later. But when I returned at 6 months to visit him, it was obvious this was more than a fussy baby.

Max would not look at me. Smiling was out of the question. He stiffened his entire body when I picked him up. He would not cuddle. He would not let me read him a book on the couch. He became inconsolable when he was agitated or upset. There was only one thing that worked for me and eventually calmed him at 6 months of age at night. Walking around the room, bouncing him and singing the ABCs over and over and over again — until his crying subsided and he collapsed from exhaustion. There was no other song that worked. As a toddler, we had to physically lock him down in a highchair to feed him. He only ate two things — an oatmeal gruel with banana and honey blended. No banana lumps allowed. And finally, Stauffer's lasagna for lunch and dinner cut into the tiniest of pieces every day. His parents eventually were able to add items to his diet by age 6 or 8 and his list was up to 12 — Cheerios, Kraft's Macaroni and Cheese and square Triscuits. Not the triangles. And only McDonald's fries would do. I once was desperate and snuck Burger King fries into a McDonald's red box. He wouldn't touch them.

Today Max is a strapping 6-foot, 15-year-old boy and talks with a very deep, mechanical voice. He now eats like a teenager. When we are out and about, I rarely have to explain to people that Max is autistic. He's very sweet. Kind. He jumps when he's happy and flaps his hands, which is often. He's supersmart. He's a wiz at math and knows all three Japanese alphabets, every country and capital in the world and every flag. He plays a mean Bach on the plano.

Yes. My support for We Are Up is very selfish, I know. The truth is at this point, Max may never live there because his parents have other ideas. But I fully understand the need for adult housing for all the other Maxs in the world.

I will continue to financially support We Are Up in the coming years if not for Max, then for all the other Maxs. I hope you will, too.
