DISCUSSION

The City of Eureka and the Humboldt No. 1 Fire Protection District jointly provide fire service for the greater Eureka area under a Joint Powers Authority agreement, as Humboldt Bay Fire. The JPA was adopted in 2011, and each entity shares the cost of maintaining Humboldt Bay Fire. The funding for Humboldt No. 1 Fire Protection District come from assessments on properties within the District.

Humboldt Bay Fire has five stations covering Eureka and the greater Eureka area. This assessment would generate the revenue required to maintain staffing and services at the area fire stations.

The City owns properties outside City limits, within the Humboldt No. 1 Fire Protection District. The City has received Assessment Ballots from the District, to decide whether or not the proposed on

The City owns a total of 14 properties in the District which and the assessed amount for 2024 is \$204. This amount would be assessed annually.
