NARRATIVE / SUMMARY

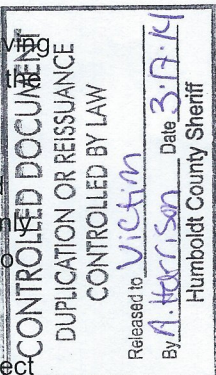
On September 06, 2013 at about 1305 hours, I was dispatched to Miranda's Rescue, 1603 Sandy Prairie Rd. regarding a trespassing issue.

On arrival I met with Ricky Wright, who told me the following: This morning one of her hired workers saw several subjects trespassing on her property, 97 Ward Creek Rd., and Ricky wished to pursue prosecution for trespassing.

I then spoke with Peter Harrington who witnessed the trespass. Peter told me the following: He was leaving the property this morning and saw three vehicle parked along the roadway, as well as subjects jumping over fence onto Ricky's property. Peter confronted the subjects by yelling, "get off my property." One of the subjects identified himself as being with Animal Control, and told Peter that the Sheriff's Office knew he was there. Peter walked toward the subjects and yelled at them to get off the property. The subject who had told Peter he was with Animal Control, turned his right side toward Peter and put his hand on a pistol carried openly on his right hip. Peter told the subject, "What are you going to do, shoot me." Then again told the subjects to leave. The subjects walked back to the vehicles and drove away.

Peter then drove to Miranda's Rescue to tell Ricky about the incident. While there Peter saw a poster featuring the subject from Ricky's property. Peter was certain the subject from Ricky's property and the subject in the poster were the same person.

I then spoke further with Ricky, and with Shannon Miranda. Shannon has been having on-going problems with a Marianna Mullens, who has hired Jim Filameo as a private investigator. The poster from which Peter identified Jim Filameo was displayed in the office, informing employees to call the Sheriff's Office if either Jim or

Marianna were seen on or near the property. Ricky re-iterated that she wished to pursue prosecution for trespassing.

I provided Ricky with this case number and advised her to contact the DA's Office regarding prosecution.

On September 09, 2013 at about 1040 hours, I spoke with Jim Filameo by telephone. Jim told me that he is a licensed private investigator, and was in the area of 97 Ward Creek Rd. to investigate allegations of animal cruelty. Jim denied having been on Ricky's property, but did access the area via a private timber company road. Jim told me that one of people he was there with did cross the fence onto Ricky's property against Jim's wishes. Jim's plan was to attempt to photograph the animal's in question from the roadway. Jim told me that he is licensed to carry a firearm, and was carrying a pistol, but at no time did he draw the weapon, or even place his hand on it. Jim denied having represented himself as being with Animal Control, but said he did tell Peter he was investigating animal cruelty.
