NARRATIVE / SUMMARY

On 05-23-13, at about 0953 hours, I was dispatched to contact (C) Shannon Miranda regarding a report of a break-in to Miranda's Rescue office located at 1695 Drake Hill Rd., Fortuna. I first contacted Shannon at the phone number provided. Shannon told me that sometime during the night someone had broken into the Rescue office and stole files pertaining to certain dogs that are at or have come through his rescue. I ended the phone call with Shannon and responded to the rescue to meet with him for further details. Upon arrival, I met with Shannon and he told me the following:

Shannon and his partner Dean Paris were at the Rescue office until about 8:45 pm on 05-22-13, and had received two dogs between 7:45 and 8:45 pm. While there, Shannon and Dean noticed a red Ford F250 driving up and down Drake Hill Rd., slowly several times. Shannon observed that there was a WMA driver, and that he appeared to be looking for something. Afterward they closed and locked the office and closed and locked the gates to the yard. The office is located behind a large cyclone fence. The office is where Shannon keeps all of his records of the animals that come into and are adopted out of the rescue.

When Shannon arrived this morning at about 8 am, he noticed that the blinds to one of the windows were messed up. When Shannon asked about it his employee, Andrea Russell, told him that when she arrived at 7:30 am she found the window open, files on the floor and the blinds messed up. Andrea told Shannon that she thought the office cat may have caused the mess. Shannon inspected closer and found pry marks on the outside window frame and found that there were files missing from his desk. Shannon noted that the files that

were missing were files that he had been being harassed about by a particular person.

Shannon often receives dogs from shelters in Southern California, many of which are pit bulls. Several months ago, Shannon had been contacted by Marianna Mullins and asked to take three dogs for re-hab and adoption. Shannon took the dogs and two of them were successfully adopted out. Marianna had been inquiring about the dogs and wanted the contact information of the adoptive families from Shannon. Due to privacy rules, Shannon did not provide this information to Marianna and she became angry with Shannon. One of the dogs, Big Boy, after being adopted out had jumped out of a vehicle while parked and got hit by a car killing him. The other, Buddy, had to be euthenized by the adoptive family after he killed another dog and bit a small child.

Shannon informed Marianna of these incidents when she inquired about the dogs after the fact. Shannon felt that this information angered Marianna as he began receiving texts, e-mail, and Facebook post by her that were accusing him of being a fraud and not taking care of the dogs as he professes to do. In her messages and posts, Marianna, continues to question Shannon as to the where abouts of several dogs, requesting photos of them and commenting that "Justice will be served."

Based on this recent harassment and Marianna's interest in the information in the files that were taken, Shannon is of the belief that she may have had something to do with the break in. Shannon had no further information at this time. I check the window and did not find any possible useable latent prints.

I contacted Marianna via the telephone number provided by Shannon. I asked Marianna if she knew anything about Shannon's office being broke into or particular files regarding dogs of interest to her being taken. Marianna told me she had nothing to do with it and that Shannon should consider whether it was an inside job. Marianna told me that she has been working with a private investigator, Jim Filomeo, of Eureka, regarding Shannon rescuing pit bulls that seem to disappear after he takes them. Marianna had no further information but provided me with Filomeo's phone number.

I contacted Jim Filomeo at the phone number provided. Jim confirmed for me that he was working with Marianna in regards to complaints that Miranda's Rescue takes in several pit bulls from out of the area that seem to disappear. Filomeo told me that he believes Shannon has the dogs euthenized and then buried on the Jackson Ranch in Blue Lake. I told Jim that I was investigating a break in to Miranda's office where several files pertaining to dogs of Marianna's interest were taken. Jim told me he knew nothing about the break in.

I re-contacted Shannon and advised him that without further information or evidence this case would be stalled. Shannon could not provide any further information. I suggested that Shannon consider a restraining order against Marianna if the harassment continued. I also instructed him to consider further security measures for his office.

Nothing further at this time. Any further information will be made a matter of written report.
