RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE OF AVENUE OF THE GIANTS AND CONTROLLED TRAFFIC ON THE MATTOLE ROAD TO ENSURE THE SAFETY OF RUNNERS PARTICIPATING IN THE SIX RIVERS RUNNING CLUB'S 52TH ANNUAL AVENUE OF THE GIANTS MARATHON, HALF MARATHON AND 10K RACE ON SUNDAY, MAY 5th, 2024 BETWEEN THE HOURS OF 7:30AM AND 2:30PM.

WHEREAS, the Six Rivers Running Club is planning the 52TH Annual Avenue of the Giants Marathon, Half Marathon, and 10K Race for Sunday, May 5th, 2024 between the hours of 7:30 a.m. to 2:30 p.m.; AND

WHEREAS, road closures and controlled traffic are necessary to ensure the safety of runners participating in the marathon.

NOW THEREFORE BE IT RESOLVED THAT:

On Sunday, May 5, 2024:

1. Both lanes of Highway 254 from the southern Redcrest exit from Highway 101 to a point 6.55 miles south of the Dyerville Bridge. During the event Highway 254 will be closed to all traffic except for official race support and emergency vehicles. People attending church or leaving/returning home would also be allowed to pass.
2. Both lanes of the Mattole Road will be controlled by Wes Nalley Stop N Go traffic support pilot cars from the Dyerville Bridge (Honeydew Founders' Tree exit from Highway 101) to a point 6.55 miles west on the Mattole Road.
