• Upon the County determining phase one has been constructed, planted, and harvested in compliance with all terms and conditions of this permit, phase two is authorized to proceed and the same process shall be used to evaluate each subsequent phase, with no more than one additional phase allowed per year.

• The results of the annual review shall be discussed at a public meeting in front of the Zoning Administrator. The Zoning Administrator shall not approve a subsequent phase if violations are unresolved for the preceding phase. The action of the Zoning Administrator may be appealed with no fee for concerns related to provisions contained within this permit.

5. Once operations start, the Applicant shall dedicate an employee to serve two hours per week, in

the volunteer services supporting the community.

6. The applicant shall provide up to \$20,000 matching funds within the first 5 years to matching funds obtained by the Community for roadway safety improvements. For improvements initiated by the community.
