# A. Consider Resolution No. 234-36, A Resolution of the City Council of the City of Arcata Calling for Peace in the Middle East.

During the February 21, 2024, City Council meeting, after public comment the Mayor received input from at least three Councilmembers that there was interest in considering a resolution supporting peace in the Middle East. This sentiment was in part due to continued work in the community to bridge communication between individuals and groups with many perspectives on the war and their work to develop resolution language that would also seek to heal and not further divide the community over the Israeli-Hamas War.

## **RECOMMENDATION:**

It is recommended that the Council consider Resolution No. 234-36, A Resolution of the City Council of the City of Arcata Calling for Peace in the Middle East.

B. Consider Adopting Resolution No. 234-34, A Resolution of the City Council of the City of Arcata Accepting the Mid-Year Budget Review and Approving Budget Revisions for the Fiscal Year 2023-24.
