Dear Planning Clerk:

The District has reviewed the Tentative Parcel Map dated 05-02-2023 for the above referenced project. We offer the following as conditions for the proposed minor subdivision:

- 1. Water and sewer services for any future development are available upon payment of applicable fees.
- 2. Any future living unit development on Parcel 2 will require connection to the public sewer system.
- 3. Each separate parcel shall have water and sewer services serving only that parcel. There shall be no services shared between separate, legal parcels.
- 4. Water and/or sewer services crossing adjacent properties, shall have appropriate easements.
- 5. A landscape sprinkler system requires a water backflow prevention device in accordance with the District's Cross-Connection Control Program.
- 6. Water and sewer services should not be located in a driveway, or parking area. Water and sewer lines shall meet or exceed minimum cover requirements.
