Subject:	Anticipated Unspent Future of Public Health (FoPH) Funds for Fiscal Year (FY) 2022-2023 and Redistribution Process

## I. Purpose

This memo provides an overview of the Future of Public Health (FoPH) funding redistribution process of anticipated unspent funds for fiscal year (FY) 2022-2023.

## Overview

The Future of Public Health (FoPH) funds that are allocated to all 61 LHJs are intended to fill in the public health gaps exacerbated and magnified during the COVID-19 response and increase capacity of local public health jurisdictions to be prepared for the next large-scale emergency. The goal of this local funding redistribution process is to ensure FY 2022-2023 funds are used to support the infrastructure and workforce of local health jurisdictions. CDPH is committed to working in partnership with LHJs to identify strategies to spend down FoPH funds and ensure that these funds continue to be available in future years.

Based on submitted and processed invoices to date, CDPH RPHO anticipates that there would be unspent funds for FY 2022-2023. CDPH RPHO, in partnership with the County Health Executives Association of California (CHEAC), sent a reconciliation drill for LHJs to review accuracy of expenditure data. LHJs were also asked to provide additional information on their plans for spending, including identifying any projected unspent funds for FY 2022-2023. The goal of this exercise was to identify anticipated unspent funds to support a plan to redistribute funds to eligible LHJs who report a need and can attest that they can spend the additional dollars by June 30, 2024.

Approximately \$13 million of FoPH funds from FY 2022-2023 were identified as projected to be unspent. All remaining unspent funds must be encumbered or expended by June 30, 2024. It is encouraged that LHJs submit final invoices as close to the end of the funding cycle on June 30<sup>th</sup>, 2024, as possible and it is recommended that all invoices are submitted within 90 days from the end

of the funding cycle. This process is specific only to FY 2022-2023 funds and does not impact or change future year allocation amounts.

For the purpose of this memo, the term redistribution will be defined as the process for which FY 2022-2023 funds will be redistributed from one LHJ to another LHJ on a one-time basis. This process is specific only to FY 2022-2023 funds and does not impact or change future year allocation amounts or methodologies.

CDPH RPHO has developed guidance for redistribution of these unspent funds as described below in section II.

## II. FoPH Funding Redistribution Process

- 1. CDPH RPHO will directly contact LHJs who identified having anticipated unspent FY 2022-2023 funds in the reconciliation drill to confirm the reported total unspent funds. This confirmation process will allow CDPH RPHO to verify the total funds available for redistribution.
  - a) LHJs will be required to confirm total anticipated unspent funds by February 14<sup>th</sup>, 2024. If LHJs do not respond, the anticipated unspent funds reported in the reconciliation drill will be assumed as confirmed unspent funds.
  - b) Any LHJ who may not have identified anticipated unspent funds through the reconciliation drill and have since identified anticipated unspent funds may contact CDPH RPHO at <u>FoPHfunding@cdph.ca.gov</u> to indicate unspent funds available for redistribution.
- 2. CDPH RPHO has identified LHJs who are eligible to receive redistributed funds via the FoPH redistribution process. An LHJ is considered eligible if they have invoiced equal to or greater than 60% of their FoPH FY 2022-23 existing allocation as of January 1<sup>st</sup>, 2024. This criteria was developed in partnership with the California Conference of Local Health Officers (CCLHO) and CHEAC Executive Committees. Eligible LHJs will also be directly and individually contacted by CDPH RPHO.
- 3. Eligible LHJs will have the opportunity to submit a brief written proposal for a funding amount they have identified as needed and can be spent by June 30<sup>th</sup>, 2024. Please note the following important details:
  - a) Proposals should include details on how the LHJ plans to spend the funds and include the requested amount to fund the proposed activities.
  - b) Proposals from LHJs who have spent equal to or more than 74% of their FY 2022-2023 allocation will be given priority in review and approval of submitted proposals.
  - c) If the proposals submitted exceed the available funding, CDPH RPHO will engage in a proposal prioritization process with input from CCLHO and CHEAC Executive Committees.
  - d) All LHJs that submit a proposal must be prepared to demonstrate their ability to encumber the redistributed funds by the end of the funding cycle on June 30<sup>th</sup>, 2024.
- 4. All proposals must be submitted to CDPH RPHO by February 23<sup>rd</sup>, 2024, for review and consideration. Eligible LHJs will be contacted to confirm approval of their proposals by February 28<sup>th</sup>, 2024.
  - a) If the eligible LHJ elects to receive the proposed redistributed funding, the CDPH FoPH Redistribution Agreement form must be submitted to <u>FoPHfunding@cdph.ca.gov</u> inbox by March 1<sup>st</sup>, 2024.

The additional funding redistributed to eligible LHJs will be subject to all existing funding requirements and guidance as noted for FoPH FY 22-23 funding permissible uses. LHJs may reference the latest funding reference guide for more information.

Below is a summary of key dates relative to FoPH fund redistribution:

Date	Activity
February 9, 2024	LHJs must confirm amount of anticipated unspent funds (Note: If no response is received by your LHJ, the previously reported amount will be assumed as confirmed unspent funds.)
February 16, 2024	LHJs that believe they should be eligible to receive redistributed funding must notify CDPH
February 23, 2024	LHJs eligible to receive redistributed funding must submit a brief proposal request to CDPH for review
February 28, 2024	LHJs selected to receive redistributed funds will be contacted by CDPH to confirm approval of their proposal
March 1, 2024	LHJs selected to receive redistributed funds must submit to CDPH the FoPH Redistribution Agreement Form

## **Eligibility Criteria**

In order to be eligible to receive redistributed funding from FY 2022-2023, LHJs must have demonstrated, based on CDPH RPHO funding tracking records, that they have spent equal to or greater than 60% of their FY 2022-2023 allocation. Proposals from LHJs who have spent equal to or greater than 74% of their FY 2022-2023 allocation will be given priority in review and approval of submitted proposals.

CDPH RPHO has identified the following LHJs who are eligible to receive funding via the redistribution process. If any LHJ believes that they have met eligibility requirements and are not documented on the following list, please reach out to <u>FoPHfunding@cdph.ca.gov</u> no later than February 16<sup>th</sup>, 2024, to confirm eligibility.
