4. Describe how the scope of your proposal fits the intent of *Measure Z*. Specifically, how will it maintain and improve public safety and essential services, as described on the previous page?

The Juvenile Diversion Program (JDP) improves public safety by providing criminal prevention and intervention services to the schools and families in the Arcata/McKinleyville area. The Juvenile Diversion Counselors (JDCs) provide Brief Intervention drug and alcohol counseling to students as well as Victim Assistance/Youth Accountability Counseling to those youth who have committed minor crimes within the community. JDCs provide counseling and case management services to victims of child abuse and neglect. They attend Arcata High School's Absenteeism Intervention Mentors meetings and reach out individually to struggling students and their families to identify barriers to attendance and discuss reasonable solutions to improving attendance. JDCs also affect whole family units by teaching a minimum of two 10-week long parenting classes each year.

5. Please provide a brief description of the proposal for which you are seeking funding.

The City of Arcata, in collaboration with the Northern Humboldt Union High School District, local elementary school districts and juvenile justice partners, seek Measure Z funding for one Juvenile Diversion Counselor (JDC) to directly serve K-12 students and families in the 3rd Supervisorial District and the western portion of the 5th Supervisorial District (West of Berry Summit). Juvenile Diversion plans to expand our impact by improving and increasing support for Juvenile Probation by offering Restorative Practices, Brief Interventions, Absenteeism Prevention, and Parent Project trainings to students and families. With Juvenile Detention centers in California being closed in 2023, it is imperative that our agencies create new strategies to best meet the needs of our at-risk population.

The JDCs have bases at both Arcata High School and McKinleyville High School. They will work collaboratively with the schools, APD, HCSO, and Probation to identify and serve at-risk students and families starting as early as grades one and two. The purpose is threefold:

- (1) Focus on crimes and other antisocial behaviors committed by juveniles in the north county and through that focus, deter additional behaviors.
- (2) Utilize the Juvenile Diversion Counselors to keep juveniles out of the Probation and Juvenile Justice system.
- (3) Work with the schools to support struggling families and students so their children remain in school (truancy prevention) and out of the Juvenile Justice system.

The project's goals are to:

a. Significantly reduce the amount of juvenile crime in the service area, significantly reduce the number of high school students who drop out and/or go to continuation high schools over a five-year period.

6. How have you developed a plan for sustainability, including diversification of funding sources, for your proposal to carry on without reliance on future *Measure Z* funds? Please provide detail of your plan for sustainability here.

JDCs regularly search and apply for additional grants that are relevant to the program. Juvenile Diversion was recently awarded a Board of State and Community Corrections (BSCC) Title II grant to help fund the Parent

Project in Arcata and Fortuna. AJD also collaborated with Northern Union High School District to obtain grant funds from the US Department of Education. Those funds will cover the salary of one of two JDCs for one year in exchange for services directly provided to district students.

7. If this request is for the continuation or expansion of an existing program/service, what is the current source of funding for that program/service?

This request is for the continuation of a previously Measure Z funded program. Arcata Police Department is only requesting to continue the funding of one of two JDC positions and a small portion of operating costs, such as trainings, travel and materials. It is eliminating prior years' requests to fund a School Resource Officer and a second JDC. For the first half 2023-2024 fiscal year, wages for both JDCs have been solely funded by the City of Arcata. Wages for one JDC shall be reimbursed by US Department of Education grant funds during the 2024 calendar year. The City has also covered most operating costs, with the exception of the Parent Project, which is currently funded by Title II grant funds.

8. If you are awarded *Measure Z* funds, how do you plan to leverage these funds to secure additional grants, contributions or community support?

The JDP serves as a pilot for the other local schools. The benefit of keeping students in schools, on track for graduation and out of the alternative education or the juvenile justice system is potentially enormous. Students who attend and graduate from the comprehensive high schools are far less likely to commit crimes and become involved with the juvenile justice system. This model will make the consortium more likely to receive funding through the US Dept. of Justice's SRO and School Safety grant programs.

No, the Arcata Police Department has been operating the program successfully and is not dependent on another entity.

Measure Z Final Results Narrative Fiscal Year 2022-23

Juvenile Diversion addressed crimes committed by juveniles such as threats, burglary, possession of drugs, assault, and vandalism. Diversion also worked with service providers in the area to enable youth and families to gain access to mental health or Substance Use Disorder services. Our Juvenile Diversion counselors worked with local law enforcement agencies to address crimes committed against juveniles, such as neglect and sexual or physical assault. Diversion provided case management duties, such as assisting families with accessing food, mentorship, tutoring, employment, counseling and housing. Juvenile Diversion worked with students in the Northern Humboldt District who struggle with the social and emotional barriers to education. At the request of school officials, Juvenile Diversion Counselors (JDCs) conducted welfare checks and case management for youth who were not attending school, or that school staff were unable to contact or locate. Families and youth referred to Diversion through School and Law Enforcement are provided support through advocacy and accountability.

Diversion worked side by side with law enforcement to provide crisis intervention. Juvenile Diversion Counselors continued to offer direct 1-on-1 counseling, and drug and alcohol intervention for youth involved in the program. Diversion also worked closely with the administrators on over a dozen campuses to address truancy, threats of violence, drug use and sales, and physical assaults. Diversion partnered with Humboldt County Juvenile Probation to host the Parent Project. Diversion also continued to partner with Teen Court to coordinate Title II Grant funds in order to bring Parent Project classes to the Fortuna area.

Our Juvenile Diversion Counselors continue to serve the Northern Humboldt area, including McKinleyville, Arcata, Blue Lake, Trinidad and Samoa areas. JDCs provided services to K-12th grade students, young adults, and families in the 3rd Supervisorial District and the western portion of the 5th Supervisorial District (west of Willow Creek).

Diversion used best practices in supporting youth and families in our community. Juvenile Diversion participated in conversations with Mental Health, Probation, JJDPC and others to address DJJ Realignment/Secure Youth Treatment Programs in Humboldt County. Through advisory committees, Diversion also participated in conversations about the design of Direct Care with Sorrel Leaf, our new crisis intervention facility for youth in Humboldt County.

Diversion worked closely with the Chronic Absenteeism Prevention Coordinator and school admin to help students and families address barriers to education.

Referrals to Diversion were as follows: 36% school performance and attendance, 10% assault, or threats, 12% vandalism, 16% alcohol or other drugs, 26% were deemed "at-risk" or "high-risk" by outside agencies and referred to Diversion for preventative support.

Case management, family counseling, and parenting classes have been the most effective strategies of our program. Case management and family counseling allows Diversion to provide referrals, support and follow-up with local resources for struggling families and youth. During the last year, we have seen an increased need and requests for our Parent Project and Loving Solutions classes. Parents who have completed the program have all reported positive changes in their homes such as decreased arguing and conflict in the home and increased school attendance. Families from all five of Humboldt County Supervisorial Districts attend these classes.
