Moreover, Shaun:

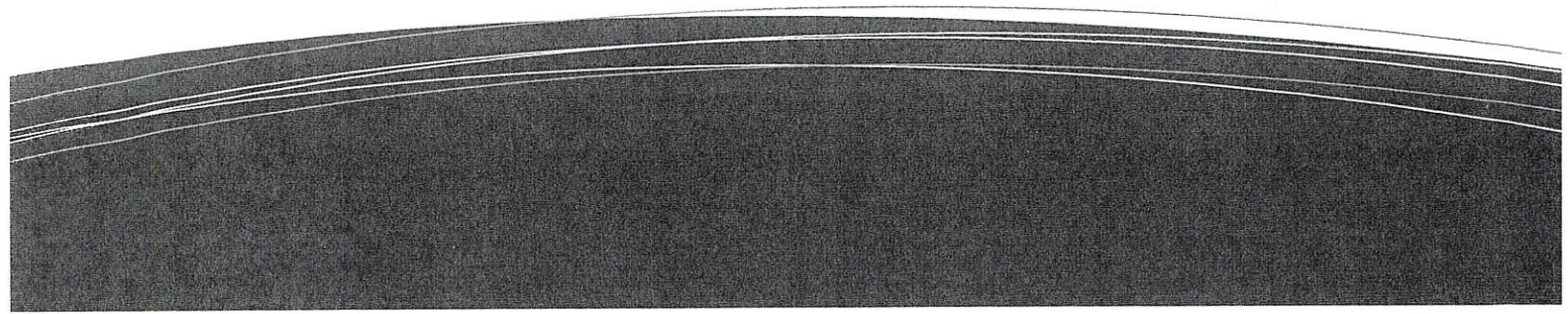
- Attends weekly meetings with his Care Coordinator.
