		REMEDY: By 12.31.2024, submit photo-evidence the prohibited material has been removed from site to an authorized waste management facility. Do not bring any more synthetic netting onsite for any purpose.	
Operation is achieving compliance schedule	NON-COMPLIANT	ISSUE: The project went into effect 02.02.2024 and generally has two years to complete all project conditions, or by 02.02.2026. However, some of the conditions were due within 60-days of project approval, including conditions #5 (execute a Compliance Agreement with the Humboldt County Planning and Building Department) and #7 (submit an energy use plan), neither of which appear to have been submitted.	
		REMEDY: Submit the overdue documents to the Planning Department within 30-days. Be aware that failure to do so may result in the permit being suspended until these conditions have been met.	
Processing in approved location(s)	NON-COMPLIANT	ISSUE: The permit allows for "Drying and curingonsite in an existing multi-use shed, with all other processing occurring offsite". However during the 2024 inspection, the operator indicated that all processing takes place onsite. The permit does not allow this.	12/31/2024
		REMEDY: By the end of 2024, submit to the Planning Department receipts or other evidence sufficient to prove that further processing occurred at a licensed processing or manufacturing facility in the 2024 season.

Water storage	NON-COMPLIANT	ISSUE: The permit requires 147,000 gallons of water storage in tanks onsite. Currently, there is 105,000 gallons water storage in tanks onsite- 42,000 gallons short of what the permit requires.	
		REMEDY: Prior to beginning the next cultivation cycle, submit photo evidence that additional storage has been brought onsite sufficient to meet the permit requirement of 147,000 gallons, OR Prior to beginning the next cultivation cycle, submit to the Planning Department a temporary cultivation reduction form stating the project will only cultivate the permitted cannabis amount that the current water storage available onsite can support. The onsite water storage capacity is at 71% of the required amount, so no more than 71% of the permitted cannabis square footage, or 33,867 square feet may be cultivated until the water storage capacity is brought up to 147,000 gallons.
