ON MOTION BY MATTHEWS, SECONDED BY SCHAEFER, AND WITH A FOUR-TO-ZERO VOICE VOTE WITH ONE ABSENCE, THE COUNCIL AWARDED A CONTRACT IN THE AMOUNT OF \$115,190 TO HELIX ENVIRONMENTAL PLANNING, INCORPORATED FOR CEQA/NEPA SERVICES FOR THE ROGER'S GARAGE AFFORDABLE HOUSING PROJECT; AUTHORIZED A 10% INCREASE FOR CONTINGENCIES; AND APPROVED NECESSARY AND ASSOCIATED RELATED ACTIONS; AND AUTHORIZED THE CITY MANAGER TO EXECUTE ALL APPLICABLE DOCUMENTS. AYES: STILLMAN, WHITE, MATTHEWS, SCHAEFER. NOES: NONE. ABSENT: ATKINS-SALAZAR (RECUSED). ABSTENTIONS: NONE.
