The following sections is hereby deleted to Title III, Chapter 33, Eureka Energy Committee Sections 33.065 through 33.068

~~§ 33.065 ESTABLISHMENT AND TITLE.~~

~~—The Eureka Energy Committee is hereby established. The Committee consists of five or seven members appointed by the Mayor and subject to approval by the City Council. Each Committee member will serve for a term of four years.~~

~~§ 33.066 ROLE OF THE COMMITTEE.~~

~~—The Eureka Energy Committee will:~~

~~—(A) Serve in an advisory capacity to the Council and city staff in all matters pertaining to climate change, energy efficiency, energy conservation and conversion to greener energy sources within the community.~~

~~—(B) Advise the City Council, Commissions, or city staff as appropriate on the potential ways for the city to generate its own energy.~~

~~§ 33.067 MEETINGS.~~

~~—Regular meetings of the Commission will be scheduled at a time agreed upon by the Commission which will facilitate the attendance and input of the public.~~

~~§ 33.068 MEMBERSHIP.~~

~~—The Energy Committee members will be selected for their interest, knowledge, or experience in climate change, energy usage, conservation, regulation and/or generation.~~
