RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EUREKA,
ACCEPTING THE CANVASS OF RETURNS AND DECLARING THE RESULTS OF
THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF EUREKA HELD ON
TUESDAY, NOVEMBER 8, 2022 FOR THE PURPOSE OF ELECTING CERTAIN
MUNICIPAL OFFICERS.

WHEREAS, a General Municipal Election was held and conducted in the City of Eureka, California, on Tuesday, November 8, 2022, for the purpose of electing certain municipal officers and for the purpose of electing the following offices for the full term of four years:

City Council Member, Third Ward
City Council Member, Fifth Ward
Mayor

WHEREAS, said general municipal election was called pursuant to Resolution No. 2022-33 and was consolidated with the statewide general election held on November 8, 2022, pursuant to Resolution No. 2022-34; and

WHEREAS, notice of the election was given in time, form and manner as provided by law, and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Charter of the City of Eureka and the Elections Code of the State of California; and

WHEREAS, the Election Department of the County of Humboldt was authorized to conduct said election and to canvass the returns and to certify the results thereof to this City Council, as provided in the Charter of the City of Eureka and the Elections Code of the State of California; and

WHEREAS, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit A”;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Eureka as follows:
