A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORTUNA RATIFYING THE FORTUNA FIRE PROTECTION DISTRICT'S ORDINANCE NO. 2025/2026-1, ADOPTING THE CALIFORNIA FIRE CODE AND THE INTERNATIONAL FIRE CODE STANDARDS PRESCRIBING REGULATIONS GOVERNING CONDITIONS HAZARDOUS TO LIFE AND PROPERTY FROM FIRE AND EXPLOSION, PROVIDING FOR THE ISSUANCE OF PERMITS FOR HAZARDOUS USES OR OPERATIONS, ESTABLISHING A FIRE PREVENTION BUREAU AND PROVIDING OFFICERS THEREOF AND DEFINING THEIR POWERS AND DUTIES

WHEREAS, on January 12th, 2026 the Fortuna Fire Protection District (FFPD) enacted its ordinance No. 2025/2026-1 adopting the California Fire Code and the International Fire Code Standards prescribing regulations governing conditions hazardous to life and property from fire and explosion, providing for the issuance of permits for hazardous uses or operations, establishing a fire prevention bureau and providing officers thereof and defining their powers and duties; and

WHEREAS, on January 12, 2026, the FFPD adopted statutorily required findings in support of Ordinance No. 2025/2026-1: and

WHEREAS, in order for the Fire Code Regulations to become effective within the City of Fortuna, state law requires the City Council ratify the FFPD action adopting its Ordinance and Resolution and thereafter forward said ratification to the California Department of Housing and Community Development.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fortuna hereby approves and adopts the following:

1. The City Council of the City of Fortuna hereby ratifies the Fortuna Fire Protection District's Ordinance No. 2025/2026-1 adopting the California Fire Code and International Fire Code Standards prescribing regulations governing conditions hazardous to life and property from fire and explosion, providing for the issuance of permits for hazardous uses or operations, establishing a fire prevention bureau and providing officers thereof and defining their powers and duties, a copy of which is attached hereto as Exhibit "B" and incorporated herein.
2. The City Council of the City of Fortuna hereby ratifies the express findings made by the FFPD, as required by state law, in support of Ordinance NO. 2025/2026-1 as stated in FFPD Resolution No. 2025/2026-3, a copy of which is attached hereto as Exhibit "C" and incorporated herein.

3. The City Council of the City of Fortuna hereby directs the City staff to forward a copy of this Resolution, with attachments, to the California Department of Housing and Community Development.
