

**FIRST AMENDMENT
LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT
BY AND BETWEEN
COUNTY OF HUMBOLDT
AND
MISSION LINEN SUPPLY
FOR FISCAL YEARS 2024-25 TO 2025-26**

This First Amendment to the LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT dated March 17th, 2020, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Mission Linen Supply, a California corporation, hereinafter referred to as "CONTRACTOR," is entered into this 17th day of March, 2025.

WHEREAS, COUNTY desired to retain linen and laundry services from CONTRACTOR and CONTRACTOR desired to provide such services to COUNTY; and

WHEREAS, on March 17th, 2020, COUNTY and CONTRACTOR entered into a LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT to retain linen and laundry services from CONTRACTOR; and

WHEREAS, the parties now desire to amend certain provisions of the LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT to extend the term thereof; and

WHEREAS, the parties now desire to amend certain provisions of the LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT to increase the maximum amount payable thereunder.

NOW THEREFORE, the parties hereto mutually agree as follows:

1. Section 2 (TERM OF AGREEMENT) of the LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT, is hereby amended to extend the Agreement for an additional one (1) year at agreed prices.
2. Section 3 (COMPENSATION) of the LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT, is hereby amended to increase the maximum amount payable by COUNTY from Three Hundred Sixty-Five Thousand Nine Hundred Eighty-Six Dollars (\$365,986.00) to Four Hundred Forty-Four Thousand Five Hundred Dollars (\$444,500).
2. Except as specifically modified herein, the LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT dated March 17th, 2020 and all provisions therein, shall remain in full force and effect. In the event of a conflict between the provisions of this First Amendment and the original LINEN & LAUNDRY SERVICE UMBRELLA AGREEMENT, the provisions of this First Amendment shall govern.

IN WITNESS WHEREOF, the parties have entered into this First Amendment as of the first date written above.
