# RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS PLACING A MEASURE TO UPDATE THE TRANSIENT OCCUPANCY TAX ORDINANCE ON THE JUNE 7, 2022, BALLOT

WHEREAS, on August 23, 1977, the Board of Supervisors of the County of Humboldt adopted Ordinance No. 1158 related to the imposition of a transient occupancy tax; and

WHEREAS, The Ordinance has since been amended by Ordinances 1593, 2005 and 2128; and

WHEREAS, the transient occupancy tax is used to maintain general County Services, such as 911 emergency response; rural ambulance; crime investigation/ prosecution; emergency communications systems; park maintenance; public art/ theater; and job creation programs; and

WHEREAS, the TOT is paid only by hotel and lodging guests and RV campers who stay for 30 days or less, and is not a tax on local homeowners or property owners and helps ensure that out of town visitors pay their fair share for services they use such as road or emergency services; and

WHEREAS, funds from these measures will be subject to strict accountability provisions, including annual independent audits and public review of all expenditures; and

WHEREAS, the Board of Supervisors now wishes to amend the transient occupancy tax ordinance to update the definition of "living space" and change the transient occupancy tax rate from 10 to 12 percent; and

**WHEREAS**, the Humboldt County Board of Supervisors wishes to place this general tax measure amendments on June 7, 2022, ballot for majority voter approval pursuant to Revenue and Taxation Code Section 7280 and Government Code Section 53723.

#### NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Humboldt County Hotel Tax Update Measure. To continue maintaining general County Services, such as 911 emergency response; children's mental health; rural fire/ambulance; repairing county roads; emergency communications systems; theater/public art; job training; shall an ordinance continuing	YES	
the County's existing hotel tax at a new 12% rate (paid only by hotel/lodging guests) adding overnight recreational vehicle parks/private campgrounds, generating approximately \$3,080,000 annually until ended by voters, with annual audits/public review, be adopted?	NO	

- 3. That the Transient Occupancy Tax is a general tax not raised for a specific purpose, in which the revenues from the tax will be placed in the county's discretionary General Fundfor general purposes, thereby requiring a majority vote of the voters voting in the election on the tax.
- 4. The full text of the Transient Occupancy Tax is found in Humboldt County Ordinances No. 1158, 1593, 2005, 2128 and 2690.
- 5. The County Registrar of Voters is hereby requested to consolidate the election with any and all other elections to be held on June 7, 2022, within Humboldt County. The Board of Supervisors requests the County Registrar of Voters to render all services specified underlaw, for which services the Board agrees to reimburse upon full presentation of a bill for such services.
- 6. Any and all members of the Board are hereby authorized to act as an author of any ballot argument prepared in connection with the election referenced herein, including a rebuttal argument.
- 7. The County Administrative Officer, or designee, is authorized to take all administrative actions necessary to accomplish the orders set forth in this Resolution.
- 8. Upon approval of the voters, Humboldt County Ordinance No.2690 will be operative on
