WHEREAS, **American Hospital Management Corp** submitted an application and evidence on December 30, 2016 in support of approving a Conditional Use Permit for 10,000 square feet of new Mixed Light commercial cannabis cultivation; and;

WHEREAS, the project is statutorily exempt from environmental review pursuant to Section 15270 of the State CEQA Guidelines (projects which are disapproved); and

WHEREAS, the Humboldt County Planning Commission held a duly-noticed public hearing on April 20, 2023, and reviewed, considered, and discussed the application for a Conditional Use Permit and reviewed and considered all evidence and testimony presented at the hearing.
