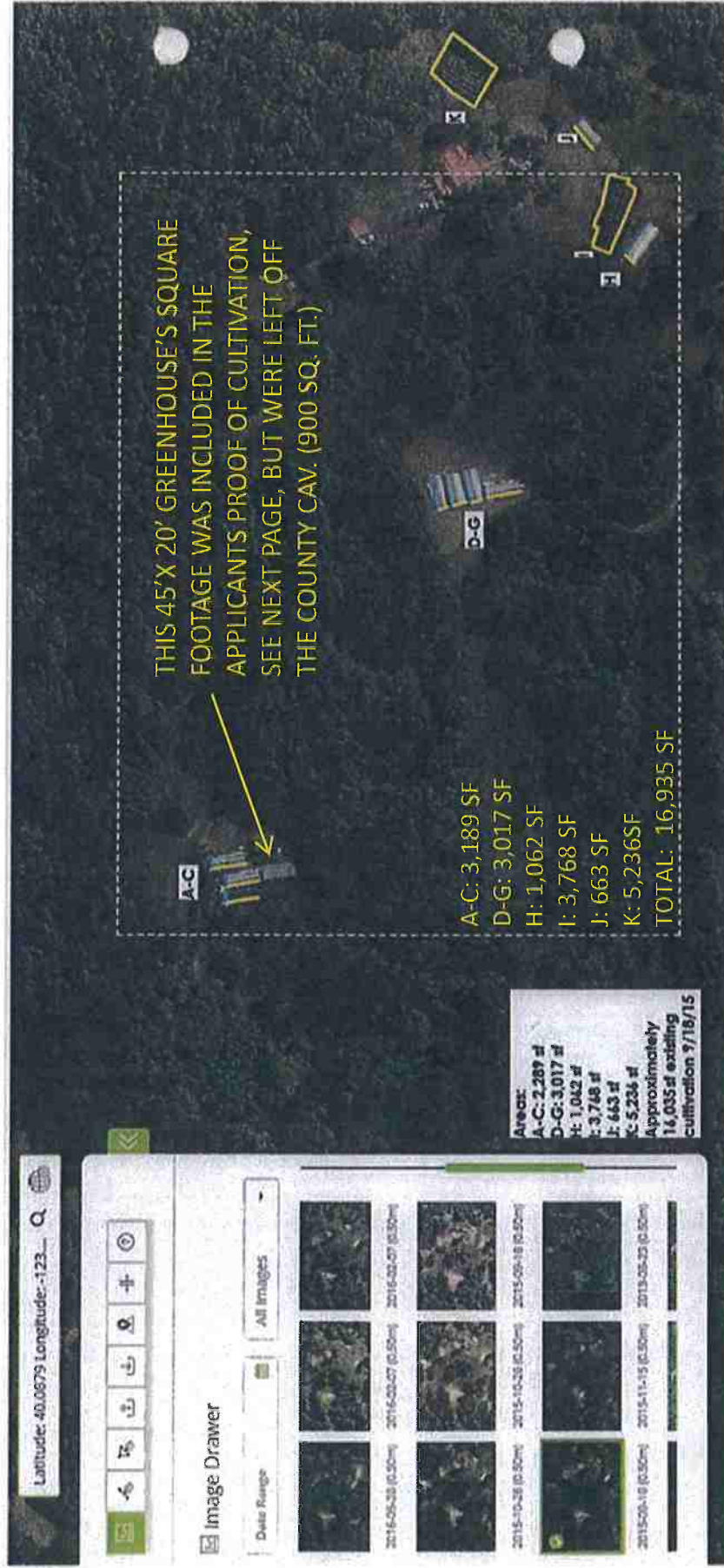

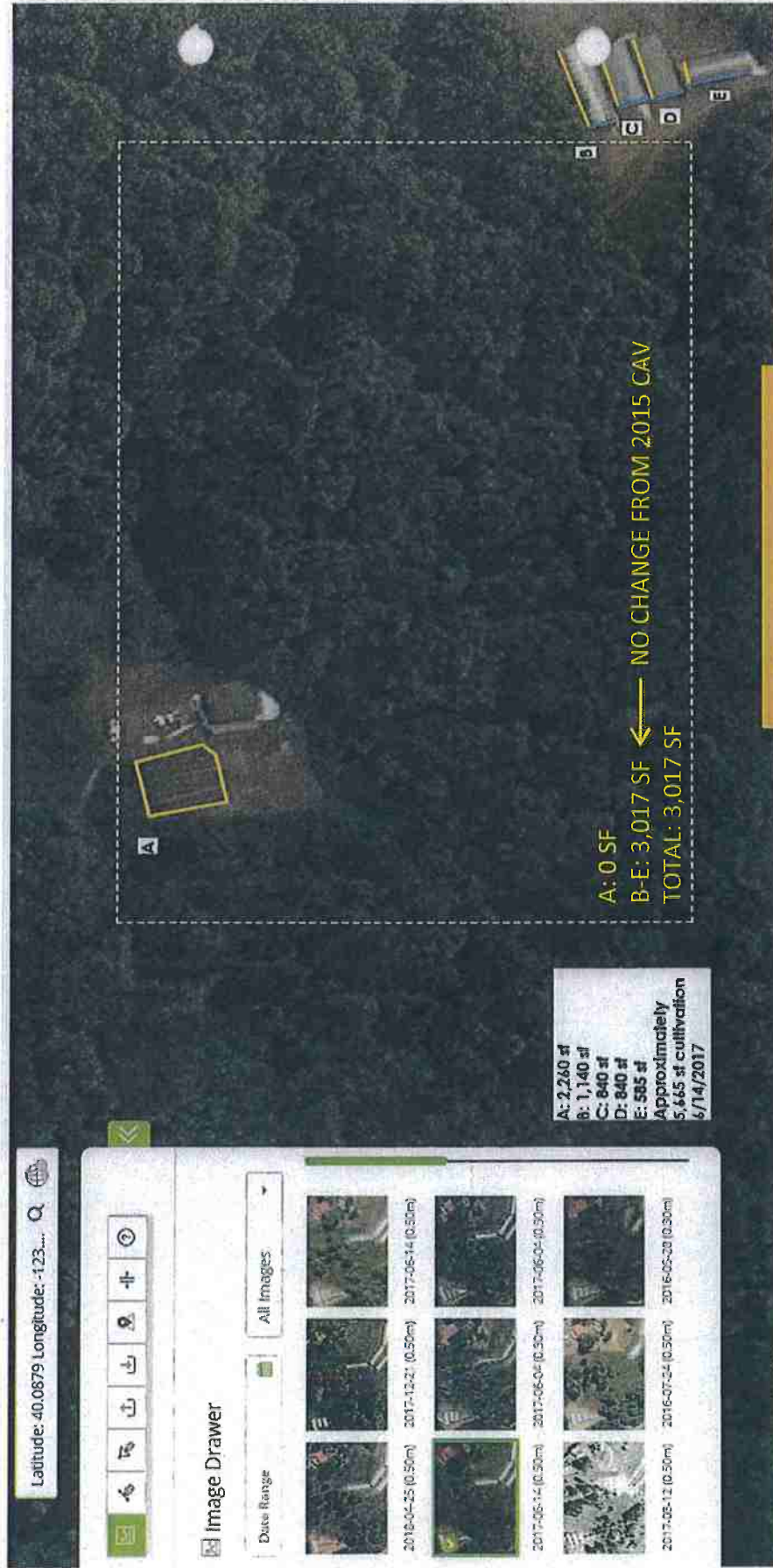

SUMMARY

- The original application submitted on 12/20/2016 provided evidence for 24,035 sq. ft. of pre existing cultivation .
- Humboldt County reviewed the evidence on 6/29/18, and came up with 16,035 sq. ft. of pre existing cultivation.
- The Humboldt County CAV missed a 900 sq. ft. greenhouse in 2015 which would have resulted in a total of 16,935 sq. ft..
- The applicant did not expand beyond the original applied for amount, and had no correspondence from Humboldt County for 18 months that would have informed him of the amount of square footage the county would allow.
- At the end of 2016, the upper cultivation areas were relocated per the direction of a resource specialist that suggested the upper gardens were too near a steep hillside. This relocation resulted in a total cultivation area of 22,651 sq. ft. in 2017, which is under the assumed amount of allowed cultivation in 2017.
- The county assumed that the area labeled "A" was in cultivation in 2017 due to the empty pots still being visible in imagery when the greenhouses were removed. Applicant certifies that the area was not in cultivation due to the relocation.
- If the County were to allow 16,935 sq. ft., and the applicant was cultivating 24,035 sq. ft. in 2018, there would appear to be 7,100 sq. ft. of excess cultivation.
- If the applicant knew that Humboldt County only wanted him to cultivate 16,935 sq. ft. he would have reduced the size of the existing cultivation area to that amount.
- Applicant proposes removing any cultivation that is above 16,935 sq. ft. and hopes that the County will accept this as a misunderstanding that has been resolved moving forward.
