Water Board Attached is the Well Completion Report for the well on the property used for cannabis irrigation. This is the sole source of water used for irrigation. No surface water diversions will occur for irrigation. An Initial Statement has been filed for the spring to be used as the domestic source of water as of 10/19/2020. The Division of Water Rights has not yet processed this Initial Statement even though it was submitted over 2 months ago. I have followed up a few times with the Division of Water Rights regarding this Initial Statement, but no WB representative has responded to my multiple requests of a status update. I tried submitting the Initial Statement submission email thread below, but the portal is not allowing any submission.
