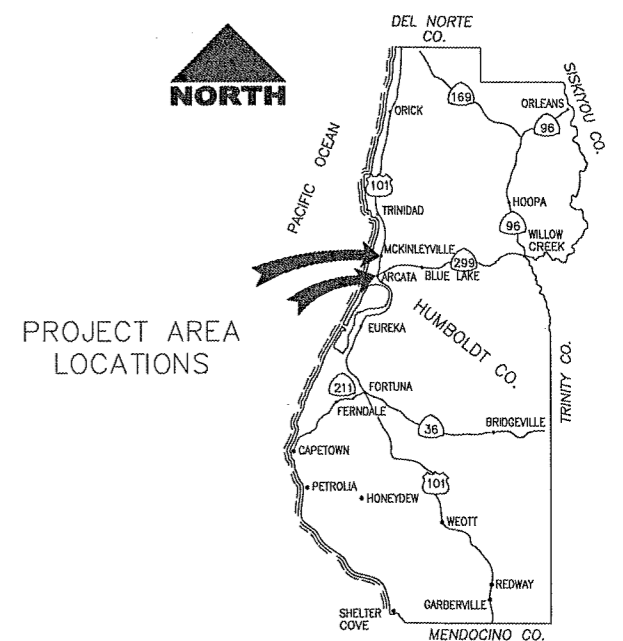

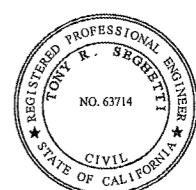

GENERAL NOTES:

- ALL CONSTRUCTION SHALL CONFORM TO THE COUNTY OF HUMBOLDT STANDARD SPECIFICATIONS, INCLUDING ALL OF THE MOST CURRENT UPDATES, ADDENDUMS AND MEMORANDUMS TO THEM.
- TWO WORKING DAYS PRIOR TO PROJECT STAKING, THE CONTRACTOR SHALL SUBMIT TO THE RESIDENT ENGINEER A COMPLETED CONSTRUCTION STAKING REQUEST FORM. CONTRACTOR R/W ACCESS: THE COUNTY SHALL PROVIDE PERMISSION TO ENTER WHERE WORK AND/OR CONSTRUCTION WILL BE DONE OUTSIDE OF THE EXISTING R/W.
- THE CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR FURNISHING, INSTALLING AND MAINTAINING ALL WARNING SIGNS AND DEVICES NECESSARY TO SAFEGUARD THE GENERAL PUBLIC AND THE WORK AND FOR PROVIDING PROPER AND SAFE ROUTING OF THE VEHICULAR AND PEDESTRIAN TRAFFIC DURING THE PERFORMANCE OF THE WORK. THIS REQUIREMENT SHALL APPLY CONTINUOUSLY AND SHALL NOT BE LIMITED TO WORKING HOURS. THE USE OF FLAGGERS, BARRICADES AND CONSTRUCTION SIGNING SHALL COMPLY WITH THE CURRENT EDITION OF THE CALIFORNIA MUTCD (2014) AND 2016 WATCHBOOK.
- THE CONTRACTOR IS RESPONSIBLE FOR DETERMINING THE LOCATION OF ALL EXISTING UTILITIES AS WELL AS PROTECTING AND REPAIRING ANY DAMAGE TO THEM. THE CONTRACTOR SHALL CONTACT UNDERGROUND SERVICE ALERT (1-800-642-2444) A MINIMUM OF TWO WORKING DAYS PRIOR TO WORK COMMENCEMENT.
- DEMOLITION OF EXISTING FEATURES SHALL BE LIMITED TO THE ITEMS SHOWN ON THE PLANS AND DESCRIBED IN THE SPECIAL PROVISIONS. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO REPAIR AND/OR REPLACE ALL EXISTING FEATURES DAMAGED BY THEIR OPERATIONS, AND AT THEIR OWN EXPENSE.
- THE CONTRACTOR SHALL POSSESS A CLASS "A" LICENSE, OR A COMBINATION OF CLASSES AS REQUIRED BY THE WORK CATEGORIES AND CLASSES OF WORK INCLUDED IN THIS CONTRACT.
- INCLUDED IN THE TRAFFIC CONTROL PLAN BUT NOT LIMITED TO: MAINTAINING TRAFFIC INCLUDES PEDESTRIANS, VEHICLES, & BICYCLES. WORK SHALL BE COMPLETED AND ALL TRAFFIC LANES SHALL BE RESTORED BY 4:30 PM EACH WORKDAY.
- ALL EXISTING CURB, GUTTER, AND SIDEWALK SHOWN TO BE REMOVED IS TO BE REMOVED OUT TO THE NEAREST EXPANSION JOINT OR SCORE MARK. DAMAGE TO EXISTING CURB, GUTTER AND SIDEWALK WHICH IS SHOWN ON THE PLANS TO REMAIN, SHALL BE REPAIRED AT THE CONTRACTOR'S EXPENSE. CONTRACTOR MUST BACKFILL ALL EXISTING, AND ANY NEWLY INSTALLED, SIDEWALK, CURB, RETAINING CURB, AND/OR CURB RAMP CONSTRUCTION ADJACENT TO EXISTING LANDSCAPING TO AVOID CREATING AN ADA TRIPPING HAZARD (VERTICAL DIFF. OF 1/4-INCH OR MORE).
- THE CONTRACTOR SHALL OBTAIN A PERMIT FROM THE DIVISION OF OCCUPATIONAL SAFETY & HEALTH [381 HEMSTED DRIVE, REDDING, CA 96002; PHONE (530) 224-4743] PRIOR TO ANY TRENCHING EXCAVATION 5 FEET OR MORE IN DEPTH. A HARD COPY OF THIS PERMIT MUST BE AVAILABLE ON THE CONSTRUCTION SITE AT ALL TIMES, AS NEEDED.
- THE CONTRACTOR SHALL BE COMPLETELY RESPONSIBLE FOR PRESERVING ALL EXISTING MONUMENTS WITHIN THE LIMITS OF THE CONTRACTOR'S WORK. CONTRACTOR SHALL COORDINATE WITH ENGINEER/SURVEYOR PRIOR TO DISTURBANCE OF EXISTING MONUMENTS, AND SHALL RESET MONUMENTS OR PROVIDE PERMANENT WITNESS MONUMENTS AND FILE DOCUMENTATION WITH THE COUNTY SURVEYOR PURSUANT TO BUSINESS AND PROFESSIONS CODE SECTION 8771.
- THE CONTRACTOR, SUBCONTRACTOR, AND/OR SURVEYOR SHALL NOT CUT PERMANENT CROSSES INTO EXISTING CONCRETE CURBS, GUTTERS OR SIDEWALKS. THE CONTRACTOR SHALL BE ASSESSED AN ADMINISTRATIVE PENALTY OF \$500 FOR EACH CROSS THAT IS CUT PERMANENTLY INTO EXISTING CONCRETE CURBS, GUTTERS AND SIDEWALKS.
- CONTRACTOR SHALL PROTECT PIPELINES, VAULTS, POLES, SIGNS, FENCING, MANHOLES, FIRE HYDRANTS, CONCRETE PADS, TEST STATIONS, VALVES, VENTS, AND OTHER APPURTENANCES WITHIN PROJECT WORK LIMITS. ANY DAMAGE TO COUNTY OR PRIVATE PROPERTY FACILITIES CAUSED BY THE CONTRACTOR, OR ASSOCIATED SUB-CONTRACTORS SHALL BE REPLACED/REPAIRED TO THEIR ORIGINAL CONDITION AT THE SOLE EXPENSE OF THE CONTRACTOR.
- DAMAGE TO THE ROADWAY OUTSIDE OF THE CURB RAMP CONSTRUCTION LIMITS IS NOT ACCEPTABLE. ANY DAMAGE ROADWAY CAUSED BY THE CONTRACTOR, OR ASSOCIATED SUB-CONTRACTORS SHALL BE REPAIRED TO ITS ORIGINAL CONDITION AT THE SOLE EXPENSE OF THE CONTRACTOR.

CURB & GUTTER

- FORMS SHALL BE CAREFULLY SET TO ALIGNMENT AND GRADE AND SHALL CONFORM TO THE DIMENSIONS AS SHOWN ON THESE PLANS. FORMS SHALL BE HELD RIGIDLY IN PLACE BY STAKES, CLAMPS, SPREADERS, AND BRACES SHALL BE USED WHERE REQUIRED, IN ADDITION, TO ENSURE RIGIDITY IN THE FORM.
- PRIOR TO THE REMOVAL OF THE FORMS, THE SURFACE SHALL BE FINISHED TRUE TO GRADE BY MEANS OF A STRAIGHT EDGE FLOAT, NOT LESS THAN 10 FEET IN LENGTH, OPERATED LONGITUDINALLY OVER THE SURFACE OF THE CONCRETE. FORM CLAMPS SHALL BE SO CONSTRUCTED AS NOT TO INTERFERE WITH THE OPERATION OF THE FLOAT.

AFTER THE FACE OF THE CURB HAS BEEN TROWELED SMOOTH, IT SHALL BE GIVEN A FINAL FINE BRUSH FINISH WITH BRUSH STROKES PARALLEL TO THE LINE OF THE CURB.
- THE TOP AND FACE OF THE FINISHED CURB SHALL BE TRUE AND STRAIGHT AND THE TOP SURFACE OF CURBS SHALL BE OF UNIFORM WIDTH, FREE FROM HUMPS, SAGS, OR OTHER NOTICEABLE IRREGULARITIES.
- WHEN A STRAIGHT EDGE 10 FEET LONG IS LAID ON THE TOP FACE OF THE CURB OR ON THE SURFACE OF GUTTERS, THE SURFACE SHALL NOT VARY MORE THAN 0.01 FOOT (1/8 INCH) FROM THE EDGE OF THE STRAIGHT EDGE, EXCEPT AT GRADE CHANGES OR CURVES.
- CURB DRAINS THROUGH EXISTING CURB FACE SHALL BE CORED -OR- REMOVE CURB AND GUTTER FOR A MINIMUM WIDTH OF 1 FOOT, OR 6 INCHES ON EACH SIDE OF THE DRAIN, WHICHEVER IS GREATER. ENGINEER MUST APPROVE THIS WORK IN ADVANCE OF ANY DEMO TO BE STARTED.

- 4' WIDE SIDEWALK REQUIRES 5'x5' PASSING AREA(S) THAT SHALL BE SPACED NO MORE THAN 200' APART.
- NOTE: SIDEWALK WIDTHS DO NOT INCLUDE CURBS. SEE CALTRANS HIGHWAY DESIGN MANUAL SECTION 105.1
- MAXIMUM SIDEWALK CROSS SLOPE IS 2%. THE COUNTY PUBLIC WORKS DEPARTMENT RECOMMENDS THAT FORMS BE BUILT TO 1.5% TO ENSURE THAT CROSS SLOPE DOES NOT EXCEED 2%. MAXIMUM SIDEWALK RUNNING SLOPE IS 5%. 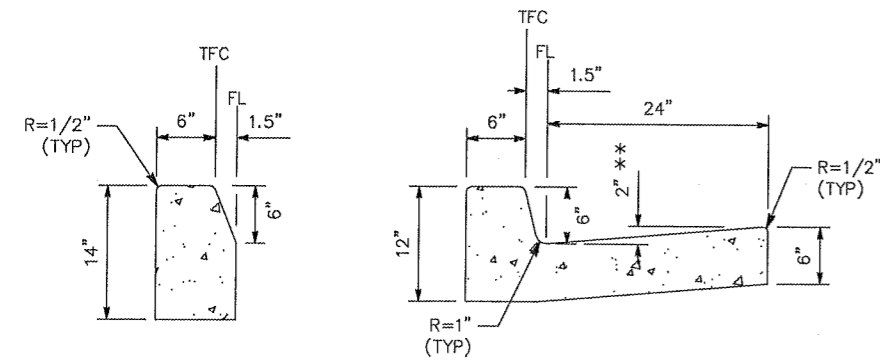

- ACTUAL ADA REQUIREMENTS ARE REFLECTED ON THESE SHEETS MAY BE DIFFERENT FROM THE REQUIREMENTS SHOWN ON CALTRANS REVISED STANDARD PLAN RSP A88A DATED 11/18/2022 WHICH WAS DEVELOPED FROM DESIGN INFORMATION BULLETIN (DIB) 82-06 DATED 11/18/2022. SECTION 4.3 (DESIGN STANDARDS) OF THE DIB STATES THAT THE REVISED STANDARD PLAN CONTAINS CONSERVATIVE SLOPES AND WIDTHS THAT ARE DIFFERENT FROM THE ACTUAL ADA SPECIFICATIONS CONTAINED IN THE DIB. THE ACTUAL ADA REQUIREMENTS ARE SPECIFIED IN SECTION 4.3.8 (CURB RAMPS) AND SECTION 4.3.5 (CROSS SLOPES) OF THE DIB.
- MAXIMUM CURB RAMP GRADE IS 8.33%. THE DEPARTMENT RECOMMENDS THAT FORMS BE BUILT TO 7.5% TO ENSURE THAT THE RAMP GRADE DOES NOT EXCEED 8.33%.
- LANDINGS ARE PIVOT POINTS. GRADES AT THE TOP AND BOTTOM OF CURB RAMP LANDINGS ARE 2% MAXIMUM. THE DEPARTMENT RECOMMENDS THAT FORMS BE BUILT TO 1.3% TO ENSURE THAT THE CROSS SLOPE DOES NOT EXCEED 2%.
- CURB RAMPS SHALL HAVE A RUNNING SLOPE NOT STEEPER THAN 1V:12H (8.3%) MAXIMUM BUT SHALL NOT REQUIRE THE RAMP LENGTH TO EXCEED 15 FEET.

SIDEWALKS

- THE SURFACE OF SIDEWALKS SHALL BE MARKED INTO RECTANGLES OF NOT LESS THAN 12 SQUARE FEET NOR MORE THAN 20 SQUARE FEET WITH A SCORING TOOL WHICH WILL LEAVE THE EDGES ROUNDED. - SURFACES SHALL BE BROOM FINISHED. SURFACES TO BE USED BY PEDESTRIAN TRAFFIC SHALL BE BROOMED TRANSVERSELY TO THE LINE OF TRAFFIC.
- THE SURFACE SHALL NOT VARY MORE THAN 0.02 FEET (1/4-INCH) FROM A 10-FOOT STRAIGHT EDGE, EXCEPT AT GRADE CHANGES, AND THE FINISHED SURFACE SHALL BE FREE FROM BLEMISHES.
- REPAIRS SHALL BE MADE BY REMOVING AND REPLACING THE ENTIRE UNIT BETWEEN SCORING LINES OR JOINTS.
- OBSTRUCTIONS: PREFERENCE IS TO MAINTAIN A CLEARANCE OF 4 FEET AROUND OBSTRUCTIONS SUCH AS UTILITY POLES, FIRE HYDRANTS, ETC. [REFERENCE: CBC 11B-403.5.1; 28 CFR PART 36 SEC 4.3.3]. A MINIMUM CLEARANCE OF 36-INCHES MUST BE MAINTAINED PER DOJ-ADA 2010 STANDARDS.

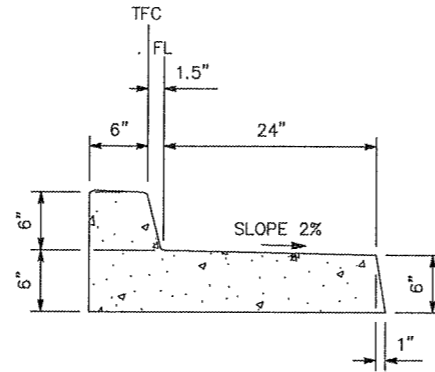

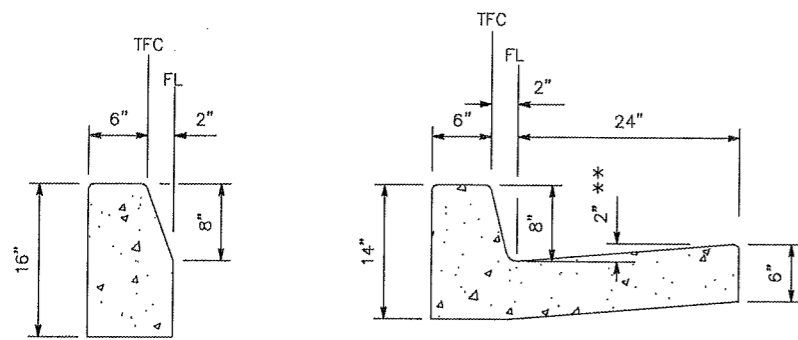

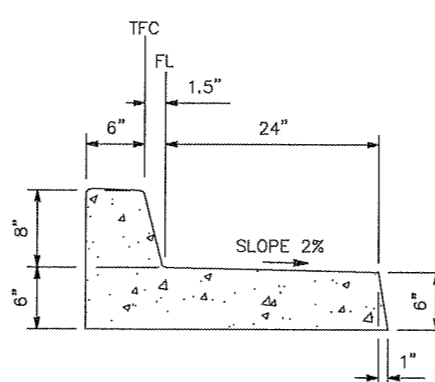
