

Northern Nights Music Festival 2022 Post Event Report UR-2021-0006 (Mendocino) PLN-2019-15400 (Humboldt)

Northern Nights Music Group

<u>Summary</u>

Northern Nights Music Festival took place on July 15th, 16th & 17th, 2022 in Piercy, CA on the Mendocino/Humboldt County Line per Mendocino Use Permit UR2021-0006 and Humboldt Conditional Use Permit PLN-2019-15400.

The following summarized key monitoring notes from the 2022 festival:

- **1.** Total event attendance was 6,587 and 2,815 vehicles with approximately 1,721 attendees camped and 1,573 vehicles parked in Humboldt County.
 - a. Traffic Plan was very effective Friday's "crunch" was managed exceptionally well by staff and 101 was kept clear. CHP did mention in their post event correspondence that they will likely increase their hours on the Monday following to cover any prolonged exodus. Shuttle system to and from down could have benefit in future years.
 - b. Camping Plan attendees cooperated with staff, fire/medical/security all were pleased with their placement and coverage it allowed.
 - c. Cannabis Plan Three cannabis event premises were operated compliantly across both counties.
- 2. Total water use during the event was 213,800 gallons. Typical property water use was reduced by over 250,000 gallons over September & October of 2022 to offset event water use. Water quality monitoring results can be found Exhibit A.
- **3.** A post event community meeting was held on August 5th, 2022 at the Piercy Community Center and notes from the meeting can also be found in Exhibit B.
- 4. The project was discussed and coordinated with Mendocino and Humboldt County Sherriff Offices, Garberville CHP, Caltrans and Piercy, Leggett, Redway and Garberville Fire Departments.
 - a. In coordination with Caltrans, an Encroachment Permit Rider was obtained for the 2022 event, authorizing emergency personnel to utilize a portion of the right of way (39.99887, -123.78750) for an emergency helicopter landing if needed during the event. This will be included in future years as well.
 - b. Applicable agency correspondence can be found in Exhibit C.

o Look into donating leftover camping gear to local homeless centers. Betty Chin's in Eureka?

- o Routine shuttle to Garberville needed.
- o Place more maps around the venue for patrons.
- o Suggests "summer pass" to combine sales for Summer Arts & Music Festival, Northern Nights, and Reggae on the River.
- CLR co-owner Matt Klyce:
 - o Improved cell service needed for patrons and local community members. Look into bringing in a temporary cell tower during the event.
 - o Fastest event has been cleaned up.
- NN site build crew member Mike Rocksteady:
 - o Road signs should be bigger.
 - o Water stations should be lit up at night so they are easier to find.
 - o Quick response by medical team.
 - o Add info kiosks on CLR and Cook's Valley sides of the event.
- NN co-producer Peter Huson:
 - o Thanks given for feedback given.

o Looking into how trash is managed. Bring in fresh crew on Sunday to start the cleanup process.

- o Offer discounted ticket price to locals.
- NN Director of EMS Amber Wallan:
 - o Improved lighting and fencing of pathways at night to be addressed.
 - o Kudos to fire, medical, and security. They all worked well together.
 - o Create a list of patrons who are caused any issues on site onsite or who cause problems (fights, etc.). If a person is on the list and is a repeat offender, they will be escorted off site immediately.
- NN co-producer Andrew Borgelt:



o Improve ticket sales locally.

o Kudos to fire, medical, and security.

Cook's Valley property owner Keith Bowman:

- o Great event.
- o Build site out for future years.
- o End result fantastic event with clean venue and river. Minimal micro trash left over.
- o Thanks given to fire for saving the boom lift fire.
- o Look into foam machines for RV fire suppression.

*Al Williams, GVFD Assistant Chief, states their engine onsite has fire foam ability but fire foam usage is being reduced and reconsidered due to cancer causing agents.

Garberville Volunteer Fire District (GVFD) Assistant Chief Al Williams:

- o Thanks given to fire extinguishers placed around the event.
- o Notify fire, medical, and security of camps that are outposts of trusted staff.
- o Requests allocation of larger fire crew onsite.
- o Fire assisted with more medical calls than in the past.
- o Guardian security team was awesome.
- o Research better ways to transport non spinal injury patients.
- o Add vendors and more food options to the CLR side and venue.
- o Fire and medical camping next to each other worked well.

Redway Volunteer Fire District (RVFD) Pete Genolio (via text):

o Parking was really good. Good job traffic crew.

Cook's Valley property owner Trudy Bowman:

o Event went good.

Community member Jeff Hedin:

- o Consider Hwy. 101 traffic and evacuation plans in the community.
 - *Amber Wallan, Director of EMS, states cars evacuated from the site will be instructed to head north to Eureka or south to Ukiah due to towns in between those areas and the event do not have the infrastructure to support evacuation traffic. In case of an evacuation, updates will be released via local radio, NN website, and NN social media.

o Wants Amber Wallan to contact community member Judith Casteel to discuss evacuation plans.

Community member and adjacent property owner Season George:

o Timbo's security crew camping on her property was ok but maybe not again in the future due to too many people there.

- o Medical team told her they were upset her property was not on the site map.
- o Surprised staff and crews didn't know her property was there.
- o Cars parked at the end of her driveway were not ok.

*Co-founder Peter Huson states security team post orders will be updated to include coverage for her property.

o Overall, best year for her.

My name is Amber Wallan and I am reaching out to you today to inform HCSO of our upcoming event this summer on the weekend of July 15-17, 2022 called Northern Nights Music Festival.

The event will take place in the **Cook's Valley Area of Piercy**, which straddles the **Mendocino/Humboldt County Line**. The event hosts 8,000 beating hearts (2,000 staff + 6,000 attendees) for three nights of performances & camping.
