SUBJECT:

Annual renewal of Plan of Cooperation between Humboldt County Information Technology Division and the North Coast Regional Department of Child Support Services (NCR DCSS) for Fiscal Year 2023-24

RECOMMENDATION(S):

That the Board of Supervisors:

1. Authorize the County Administrative Officer and Child Support Director to enter into the annual renewal of the Plan of Cooperation between Humboldt County Information Technology Division and NCR DCSS.

DISCUSSION:

The NCR DCSS has worked with the Humboldt County Information Technology Division for years. A renewal Plan of Cooperation agreement is signed annually to reflect changes in cost and support services required. The estimated charge for support services in fiscal year (FY) 2023-24 is \$100,291. These charges will be for staff time and other overhead costs such as utilities, etc.
