# **THIRD AMENDMENT** PROFESSIONAL SERVICES AGREEMENT **BY AND BETWEEN COUNTY OF HUMBOLDT** AND

### HUMBOLDT STATE UNIVERSITY SPONSORED PROGRAMS FOUNDATION

This Second Amendment to the Professional Services Agreement dated October 20, 2020 (the "Agreement"), by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Humboldt State University Sponsored Programs Foundation, hereinafter referred to as "CONTRACTOR," is entered into this day of , 2023.

WHEREAS, the Parties entered into the Agreement for Contractor to provide Workforce Innovation and Opportunity Act (WIOA) Rapid Response and Layoff Aversion Services which became effective on July 1, 2021; and

WHEREAS, the Parties previously amended the Agreement on June 28, 2022; and

WHEREAS, the Parties now wish to: (1) extend the term of the Agreement, and (2) update the Invoice that was attached to the Agreement as Exhibit B.

NOW THEREFORE, the parties mutually agree as follows:

- 1. Section 2 TERM is amended to read as follows:
  - 2. TERM:

This Agreement shall be effective commencing July 1, 2021 upon execution by both parties and shall remain in full force and effect until December 31, 2023.

- 2. The Agreement is amended to delete Exhibit D – Invoice and replace it in its entirety with the modified version of Exhibit D that is attached hereto and incorporated herein by reference as if set forth in full. The modified version of Exhibit D attached hereto shall supersede any and all prior versions thereof as of the effective date of this Third Amendment.
- Except as modified herein, the Agreement, as amended, shall remain in full force and effect. In the 3. event of a conflict between the provisions of this Third Amendment and the original Agreement or the First Amendment, the Second Amendment, the provisions of this Third Amendment shall govern.
