RECOMMENDATION:

It is recommended that the Council Adopt Resolution No. 234-13 Amending Resolution No. 167-36, A Resolution of the City Council of the City of Arcata Establishing School Zone Speed Limits on City Streets and Roads.

INTRODUCTION:

The Safer School Zone Act, also known as Assembly Bill 321 (Nava), is a state law that went into effect in 2008. It allowed cities and counties to expand 25-mile-per-hour school zones and reduce speeds immediately around schools to 15 miles per hour. The bill allowed a city or county, based on an engineering and traffic survey finding that the prima facie speed limit of 25 miles per hour is more than is reasonable or safe, by ordinance or resolution, to determine and declare a prima facie speed limit of 20 or 15 miles per hour, whichever is justified as the appropriate speed limit by that survey. The City's existing Resolution No. 167-36 is based on AB 321. More recently Assembly Bill 43, titled "Traffic Safety," was voted upon and passed by the California Assembly on September 9, 2021, and approved by the Governor and filed with the Secretary of State on October 8, 2021. AB 43 provides local authorities greater flexibility in setting and reducing speed limits in school zones to as low as 15 mph without requiring a traffic survey [revised CVC 22354(a) & 22358(a)]. This stipulation was reviewed by California Traffic Control Devices Committee (CTCDC) in 2022 and the committee approved the changes to the California Manual of Uniform Traffic Control Devices (CA-MUTCD) to implement AB 43.

DISCUSSION: City adopted a resolution 167-36 in 2017 to establish school zone speed limits on City streets and roads which followed AB 321. Since then, new schools have been established and few were missed in the 167-36 resolution. Below is the updated list of schools where the school zone speed limit of 15 MPH will be established and meets the criteria stated in AB 321

and AB 43 for speed reduction.
