- 17 1. I have personal knowledge of, and can attest to, the statements set forth herein.
- 18 2. I was the CEO of Re-Financial Servicing until the end of August 2010.
- 19 3. We never hired any person named Christopher Maguire.
- 20 4. We only ever had one person aside from myself soliciting business. His name was not
- 21 Christopher Maguire and he worked for me for a period of a few months. I believe his
- 22 name was Jason.
- 23 5. We never solicited business outside of Florida. If any business was solicited outside of
- 24 Florida under the name Re-Financial, it was done without my knowledge, and certainly
- 25 without my permission.
- 26 6. Florida's corporate records are easily available online, so anyone could have claimed to

1 work for us without our knowledge...

2 7. In September 2010 I attended Burning Man. I was involved in a week of clean-up after
3 the event, and then two weeks of traveling after that. I met a girl while at Burning Man,
4 and in October 2010, I moved from Florida to Los Angeles, California.

6 8. I never received any mail, fax, phone calls, emails, or any form of notification regarding
7 the allegations set forth in the cease and desist, or default judgment.

9 9. John DeVries is my father. He helped me set up the website for Re-Financial, and
10 occasionally provided technical support. He never participated in sales.

11 10. On the date the Default Judgment states mail was rejected by John, we were not talking
12 due to family-related differences. He never told me of the mail from the NH Banking
13 Department.

14 11. I am a law student who hopes to practice consumer protection class-action litigation.

15 12. I have finished my legal education, and will sit for the bar once I have the funds to do so.
16 (Hopefully, July 2018.)

18 13. I helped draft anti-foreclosure legislation that was passed into law in California by Mark
19 Leno's office. See attachments leading to the legislation attached here.

20 14. I contributed to the FCC issuing a policy statement that search engines, and specifically
21 Artificial Intelligence interfaces (like Siri, Alexa, etc) are subject to the same editorial vs
22 objective information classification. This helped make sure that when an AI interface
23 answers your question, there isn't any paid information in there that isn't identified. See
24 DeVries v. Apple (settled), San Francisco Superior Court.

26 15. I have helped over a million consumers across the nation by forcing a major credit bureau
27 to change their practices, and start providing the federally mandated free credit reports.

16. I've helped over a thousand employees get fair compensation in San Francisco, after a tech company was abusing labor laws. See DeVries v. Zesty, San Francisco Superior Court, CGC-17-557211.

17. I want to continue helping consumers across the nation fight against large corporations that take advantage of them everyday.


18. I fight for the little guy.
