Pursuant to the Brown Act, the City Council may not take action on an item that does not appear on the Agenda.

If necessary, an additional period shall be allotted to public comments after City Manager Reports, but only if the first 30-minute Public Comment period was not sufficient to allow all those who wished to speak to do so.
