**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARCATA  
DECLARING THE ELECTION RESULTS OF THE GENERAL MUNICIPAL  
ELECTION HELD ON JUNE 7, 2022**

**WHEREAS**, a general municipal election was held in the City of Arcata on June 7, 2022, for the purpose of filling one (1) City Council seat, for a short term ending December 2024.

**WHEREAS**, an official canvass of this election by the Humboldt County Registrar of Voters reports that a total of 4,179 ballots were cast with the following results:
